ORDINANCE(S) SECOND READING

The Following Ordinances were in City Council July 6, 2023, Read and Passed the First Time and are Severally Returned for Passage the Second Time:

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance," Approved November 24, 2014, As Amended, to change the text in Sections 1203 and 1204 regarding Temporary Mobile Food Sales.

SECTION 1. Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance," Approved November 24, 2014, As Amended, is hereby further amended by changing the text in Section 1203(C) and 1204 as follows:

1203 TEMPORARY USE STANDARDS

C. Temporary Mobile Food Sales

1. The timeframe of a temporary mobile food sales use shall be one year and approved as part of the temporary use permit.
2. The temporary use permit shall be evaluated on the basis of the adequacy of the parcel size, parking provisions, traffic access, and the absence of undue adverse impact, including noise, on other properties.
3. All mobile food establishments operating on the property shall be properly licensed by the Health Department, and/or the Department of Business Regulation, and/or Board of Licenses.
4. Sale of alcohol is prohibited in all zoning districts with the exception of the Downcity Overlay District.
5. All temporary mobile food sales establishments shall cease operation by 10 p.m.
- ~~56.~~ During business hours, a trash receptacle shall be provided for customer use and the area shall be kept clear of litter and debris at all times.
- ~~67.~~ Additional outdoor seating may be provided by the mobile food sales operator on the site, but no seating may be permanently installed.
- ~~78.~~ A permanent water or wastewater connection is prohibited.
- ~~89.~~ Electrical service may be provided only by temporary service or other connection provided by an electric utility, or an on-board generator.
- ~~910.~~ Drive-through service is prohibited.
- ~~1011.~~ A mobile food establishment is limited to signs attached to the exterior of the truck or trailer that shall be mounted flat against the truck or trailer with a maximum projection of six inches, and one A-frame sign. The A-frame sign is subject to the standards for such sign in Article 16.
- ~~1112.~~ No seating or trash receptacle is permitted to block the public right-of-way.
13. Incidental Entertainment is permitted during hours of operation.

1204 USE DEFINITIONS

Temporary Mobile Food Sales. A mobile food establishment where food or alcohol preparation and service is housed in a truck or trailer, container, or a non-motorized mobile food cart.

SECTION 1: Chapter 27 of the Code of Ordinances of the City of Providence, Entitled "The City of Providence Zoning Ordinance," approved November 24, 2014, as amended, is hereby further amended by making the following changes, with deletions struck out:

ARTICLE 12. USES

1200 Prohibited Uses

The following uses are expressly prohibited in all districts.

- a. Billboard/outdoor advertising.
- b. Halfway house.
- c. Industrial uses of the following types: abrasive, asbestos and miscellaneous nonmetallic mineral product manufacture; acid manufacture; agricultural chemicals including fertilizer manufacture; bulk storage of liquefied natural gas; cement, lime, gypsum or plaster of paris manufacture; creosote manufacture or treatment; drop forge industries; glue manufacture; leather and fur tanning and finishing; manufacture and storage of explosives; manufacture of noxious or toxic gases and chemicals; nuclear industries manufacturing; petroleum refining; primary metal industries; processing of sauerkraut, vinegar or yeast; pulp mills and paper mills; rendering or refining of fats or oils; rubber or gutta percha manufacture or treatment; tobacco and tobacco products manufacture.

- d. Landfill and garbage dump including offal or dead animal.
- e. Prison/correctional institution.
- f. Racetrack.
- g. Slaughterhouse, excluding the killing of fowl.
- h. Stock yard/feeding pen
- i. Waste incineration facility
- i. Self-Storage Facility

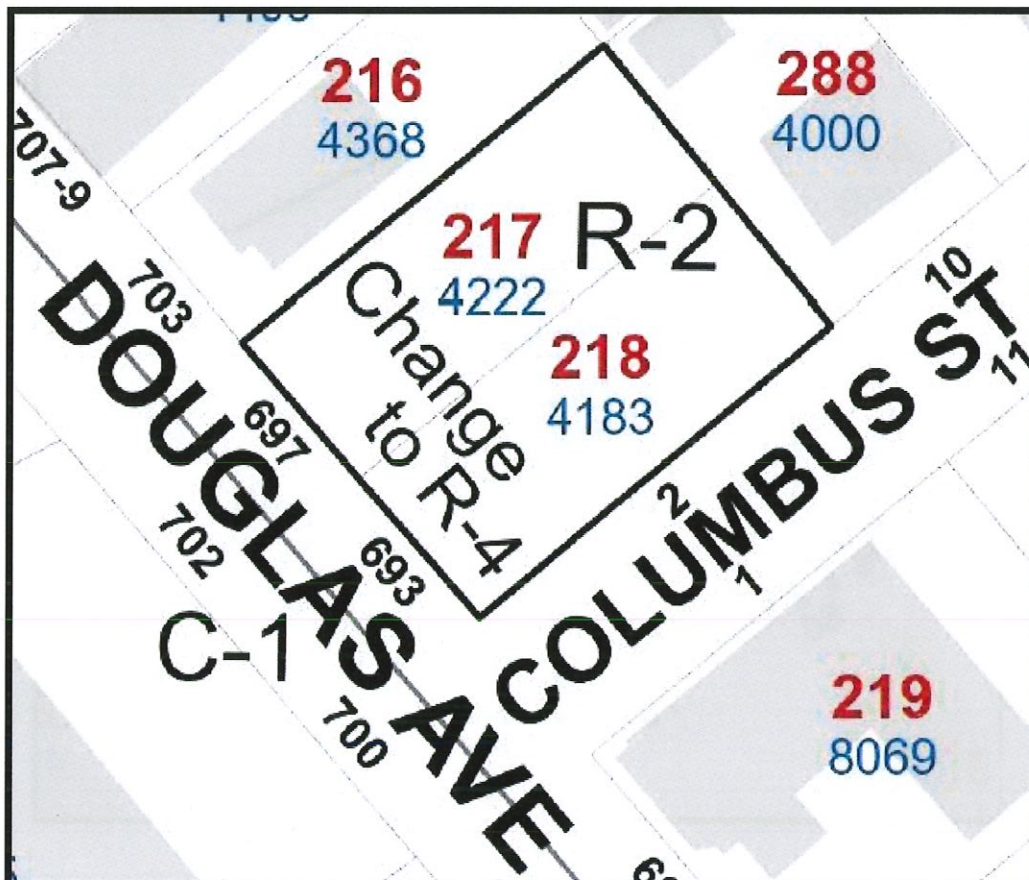

Resolution in Support of the Prohibition of Banning Books in all Providence Public Schools and Libraries.

WHEREAS, Book bans are a slippery slope that can lead to censorship, marginalization of people, and the stifling of ideas, creativity and knowledge; and

WHEREAS, In recent times, book bans, laws and policies to limit books have become increasingly common in schools, libraries, and public places around the country; and

WHEREAS, According to the American Library Association, a record 2,571 unique titles were targeted for censorship with the vast majority written by or about people of color of the members of the LGBTQIA+ community; and

WHEREAS, President Biden announced he plans to appoint a new federal coordinator to address the increase of newly state laws enacted to book bans; and

WHEREAS, With books being banned, readers are left without access to literary works that may provide essential history, education or encourage thought-provoking conversations and new ideas; and

WHEREAS, This poses a real threat to the right of individuals to access information freely and without judgment; and

WHEREAS, As books often contain different perspectives, book banning prevents readers from developing an understanding of a topic and thinking for themselves; and

WHEREAS, Book bans narrow the range of books that people are exposed to, denying them an opportunity to explore the spectrum of ideas available within a certain subject area; and

WHEREAS, Book banning can also have a detrimental effect on societies; and

WHEREAS, What's more, banning books can lead to bias and prejudice, as society becomes more entrenched in its own viewpoints and less open to alternative idea; and

WHEREAS, We must actively seek out different perspectives and strive to embrace different ideas; and

WHEREAS, This way, readers can come to their own conclusions based on the evidence presented within a book, rather than just being told what is right or wrong; and

WHEREAS, We must also look to foster an environment of understanding and acceptance by not banning books that have been deemed controversial or inappropriate; and

WHEREAS, Book banning is a dangerous practice that has the ability to limit free expression, stifle creativity and knowledge, and prevent the development of healthy dialogue within society; and

WHEREAS, If we are to truly experience the freedom of knowledge, we must recognize the importance of protecting our right to access different ideas, so that we can explore them fully and come to our own conclusions.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby supports the prohibition of banning books.

BE IT FURTHER RESOLVED, That the Providence City Council hereby supports that all public libraries in the City of Providence shall adopt the American Library Association's Library Bill of Rights that indicates materials should not be proscribed or removed because of partisan or doctrinal disapproval.

BE IT FURTHER RESOLVED, That the Providence City Council supports the prohibition of the practice of banning books or other materials within all public schools, libraries or library systems in the City of Providence.

BE IT FURTHER RESOLVED, That the Providence City Council shall eventually pass a law outlawing book bans and cut off local funding for any Providence public library that tries to ban books.

BE IT FURTHER RESOLVED, That the Providence City Council urges the general assembly and Governor McKee to sign a state law protecting the freedom of public libraries to acquire books without external limitations and strip funding from any public library that threatens to ban books.

BE IT FURTHER RESOLVED, That copies of this resolution be sent to Providence Public Schools, the Rhode Island Department of Education, Providence Public Library and the Community Libraries of Providence.

Resolution Strongly Condemning Recent Supreme Court Rulings.

WHEREAS, The Supreme Court recently struck down affirmative action in college admissions; and

WHEREAS, The decision rolls back decades of precedent and also serves as a major setback in our efforts to create a more equitable education system; and

WHEREAS, The ruling is a major obstacle to improving educational opportunity for historically underrepresented and underserved student populations; and

WHEREAS, The ruling will have a devastating effect on people of color and marginalized communities throughout our nation; and

WHEREAS, The decision reaffirms our need to continue to advocate for policies that increase educational opportunity at all levels and foster an environment where students from all backgrounds can thrive; and

WHEREAS, The Supreme Court decision in 303 Creative LLC v. Elenis also recently dealt a blow to LGBTQIA+ rights by ruling that the constitutional right to free speech allows certain businesses to refuse to provide services for same-sex weddings despite state anti-discrimination law; and

WHEREAS, This ruling will lead to more discrimination against LGBTQIA+ Americans; and

WHEREAS, These decisions of the Supreme Court serves as a stark reminder of the reality that systemic forms of discrimination continue to exist in our society; and

WHEREAS, It is our duty as a nation to combat these injustices and protect the rights of all citizens; and

WHEREAS, The Supreme Court recently also struck down President Joe Biden's plan to cancel \$430 billion in student loan debt; and

WHEREAS, As elected leaders, we have a moral obligation to stand up for those who will be negatively impacted by these rulings.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council strongly condemns and takes a stand against the United States Supreme Court's recent major rulings.

BE IT FURTHER RESOLVED, That the Providence City Council reaffirms its commitment to recognizing the strength in our diversity and forging a more equitable future for all.

COUNCILWOMAN RYAN

Resolution Requesting the resignation of Providence City Councilman Juan M. Pichardo from the Office of President Pro Tempore.

WHEREAS, Councilman Juan Pichardo was the subject of an investigation by the Rhode Island Board of Elections Campaign Finance Division for engaging in numerous violations of Rhode Island law for the period May 1, 2022 through December 31, 2022 all prior to being sworn-in on January 2, 2023; and

WHEREAS, The investigation found among other items, Councilman Juan Pichardo failed to report contributions totaling more than \$3,700; failed to accurately report contributions totaling more than \$10,600; accepted contributions from anonymous sources totaling \$275; failed to report 52 expenditures totaling more than \$5,700; failed to accurately report expenditures totaling more than \$4,300 and failed to file 6 campaign finance reports; and

WHEREAS, Councilman Juan Pichardo entered into a Consent Order May 30, 2023 with the Rhode Island Board of Elections wherein he admitted to each and every violation as presented, waived his right to appeal, challenge or deny the findings, forfeited sums and agreed to pay a \$3,000 fine; and

WHEREAS, Councilman Juan Pichardo only came public with the proceedings of the Board of Elections by releasing a statement on or about June 7, 2023, the eve before the agency released its own public statement announcing the results of its months long investigation into his voluminous violations of Rhode Island law; and

WHEREAS, Councilman Juan Pichardo as President Pro Tempore, pursuant to the Home Rule Charter in the event of a vacancy is next in succession to serve as City Council President, and second in succession to serve as Mayor of the City of Providence; and

WHEREAS, Councilman Juan Pichardo's reckless disregard for the laws governing public disclosure and reporting of campaign finance activities is chilling and an affront to honest, open and transparent government; and

WHEREAS, Councilman Juan Pichardo by his own actions, and his alone, violated the public trust and the trust of his Council colleagues. The President and President Pro Tempore are facilitators of City and Council business which requires honesty, transparency and trust among Council members. His actions have broken that trust.

NOW, THEREFORE, BE IT RESOLVED, We the honorable members of the Providence City Council hereby declare that we have lost trust and have no confidence in Councilman Juan Pichardo's ability to perform the high duties and responsibilities of the Office of President Pro Tempore.

BE IT FURTHER RESOLVED, So as to restore public trust and faith in our municipal government and affairs, we the honorable members of the Providence City Council hereby call upon Councilman Juan Pichardo to set aside his own personal ambitions for the good of the City and the Council and resign from the Office of President Pro Tempore.

COUNCILMAN TAYLOR Moves to Waive the Reading of item 27, Seconded by COUNCILOR SANCHEZ.

COUNCILWOMAN RYAN Moves to read item 27 into the record, Seconded by COUNCILMAN ESPINAL.
