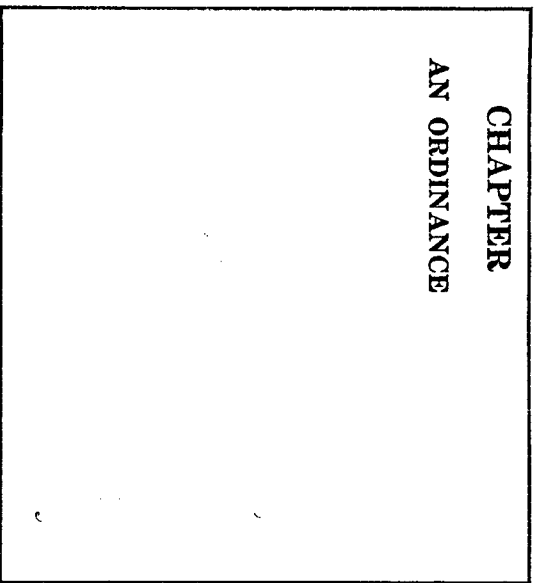

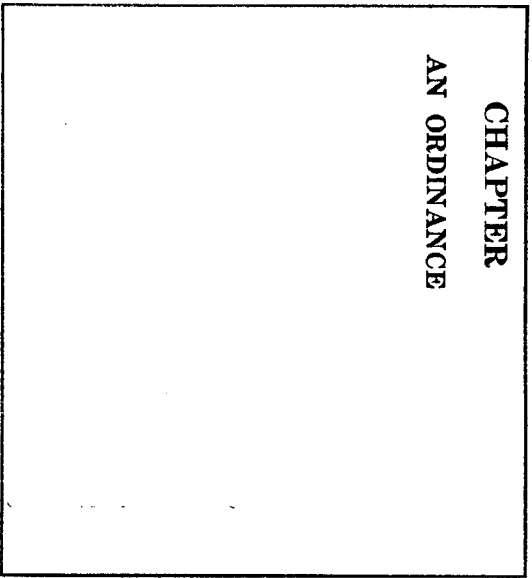

RESOLUTION OF THE CITY COUNCIL

No. 658

Approved December 6, 1957

Whereas, recent advances by Soviet Russia in the field of science made spectacularly obvious to all of us, have made it clear that we are trailing in that field so essential today for social and economic progress as well as possible survival, and

WHEREAS, studies made of the Russian educational system by the United States Government have raised doubts about the quality and adequacy of our own educational system in a period of "cold" wars which may become "hot" if we continue to lose ground in the race for knowledge, and

WHEREAS, a start must be made immediately to review the status of our own educational system here in Providence,

NOW, THEREFORE, BE IT RESOLVED, that as a contribution to National Defense and National Survival:

1. The Providence School Committee be requested to study our own educational system in light of recent developments in the field of science and education.
2. Greater emphasis be placed upon the teaching, study and development of the basic sciences, especially at the high school level.
3. Greater opportunity be afforded for the growth and development of the gifted child, so-called, in accordance with his or her capacity to learn and progress in any field of educational endeavor.

Resolved,

That the Committee on Finance is hereby authorized and directed to study the feasibility of the City of Providence establishing a scholarship fund for graduates of public, private or parochial high schools located in the City of Providence. Each scholarship award shall be in the sum of One Thousand (\$1,000.00) Dollars and shall be granted yearly to each male and female graduate of Providence high schools whether public, private or parochial, and who are residents of the City of Providence and who have demonstrated the highest knowledge and ability in mathematics and the physical sciences as determined by a recognized approved standard test in the same. Such scholarships shall be awarded to two such graduates who intend to continue the study of mathematics or physical sciences in an institution of higher learning and shall be applied against the cost of such further education. The scholarships shall be known as the "Providence Mathematics and Physical Science Scholarships" and shall be awarded under the administration and regulation of a board of five prominent educators or businessmen to be appointed by the Mayor of the City of Providence.

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, November 12, 1957.

This referral is a request for a change of zoning from an R-3 Zone to an M-1 Zone Lot 674 on Assessor's Plat 48 located at 210-212 Potters Avenue and containing 5,650 square feet of land area.


On the field trip it was found that the area in question is occupied by a three-family dwelling.

There is more than ample M-1 zoning in this area. No additional industrial zoning in this area is warranted and the proposed change would adversely affect the surrounding properties which are mostly exclusively residential. Therefore,

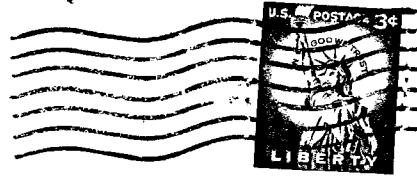
