Dear Members of the Providence School Board Nominating Commission,

I would like to be considered for the position of Providence School Board Member. I have been a resident of South Providence for 10 years and I am a graduate of the Providence Public School System. In the 1995-1997 school years, I attended Roger Williams Middle School and the Urban Collaborative Accelerated Program (UCAP). In the 1997-2000 school years, I attended Hope High School. While I do not have children or other family members presently attending public schools in Providence, my own experiences remain fresh in my mind.

In December of 2004, I graduated from Brown University with a degree in Public Policy that focused on Education. I majored in Education Policy because I wanted to understand my experiences with urban schooling and join the ranks of those who are dedicated to educational equity and empowerment. I believe the most glaring issue facing our public schools is engagement. I say engagement, with no qualifiers, because it is about holistic engagement that encompasses the community and the institutions and other entities that support it. To address the problem of achievement in Providence schools and look for ways of closing the gap, we must create better and more empathetic support networks for students *and* their families. It requires large-scale needs assessments that ask, what are the barriers that keep children in the Providence Public School System from achieving at their potential? How can we create permanent, sustainable partnerships and investments that address this risk or barrier? From poverty, to access in healthcare and safety in our neighborhoods, these are all issues that affect educational outcomes, and that can be (and are being) addressed through partnerships.

I am eager to be a member of the Providence School Board because it will be a wonderful opportunity to use my employment, education and leadership experience to continue to serve my community. As a product of the Providence Public School System, I remember feeling constantly frustrated. I believed there were no genuine opportunities for us, and chafed at the overall lack of interest and understanding of the pervasive issues we faced in and outside of school. I am now able to grasp how social, environmental and structural layers exacerbate the problems of schools like Hope; yet, I remain frustrated by the fact that many students from socio-economically disadvantaged backgrounds have to achieve *despite* the educational institutions that support them, instead of with their assistance. We hold students and teachers accountable for educational outcomes, but there are many things that can be done outside of school, in terms of policy, programming and even quality assurance that can significantly help. These are the reasons we need sustained and aligned partnerships with community organizations, as well as opportunities for cross-pollination and sharing of data and resources.

I believe that I have the skills and experience necessary to serve as a board member. I am currently working for the Rhode Island Department of Health in the Office of Families, Youth and School Successes. Though my responsibilities extend into other areas of the division, my primary tasks are of the Title X Family Planning Program Coordinator. Working as a state employee has given me a sense of how top-down policy-making and programming works. It allows me insight into how decisions are made, and resources allocated in government. I also work as an adult education teacher for the International Institute of Rhode Island. As the daughter of immigrants, teaching adult ESL is a daily reminder of the struggle of those who come to the U.S. for better opportunities. Many of them are parents of students in Providence public schools. It is unfair that they are often labeled apathetic toward their children's education. These parents come to my class after working 8+ hours in low-paying jobs, under discriminatory conditions, and they approach each lesson with a smile on their face despite tiredness, a greater hunger to learn English in order to escape linguistic isolation. These parents consistently tell me they want to learn English so that they can help their children with homework, and talk to their teachers; many of them have advanced degrees in their countries of origin, or at least some exposure to formal schooling, while others have never stepped into a classroom in their lives. These parents constantly encourage their children to succeed in school in order to achieve the "American Dream", while naive of how it plays out in the schools they attend; and these parents have to fight everyday the influence of peers and "the streets" for their child's attention.

These are the experiences that I would bring to the Providence School Board. My educational background encompasses courses that ranged from policy, politics, education and urban affairs to persuasive communication, leadership, program evaluation and the non-profit sector. My degree has afforded me the discourse, as well as the analytical thinking and functional skills needed in the professional world. My employment and community activism experience has given me the tools to effectively advocate for disadvantaged populations, in addition to the energy, discipline and patience needed to be successful.

No, I grew up in Leominster, MA, and attended public schools in that city, from 1960-1974.

My daughter attended all four years at a public high school of choice in Providence: the Met.

What do you believe are the MOST critical issues currently facing the Providence Public School System?

- **The inequality of funding across the state, which leaves Providence students at a disadvantage, and has lead to numerous cutbacks in services and personnel.**
- **The high drop-out rate**
- **The High School and Middle School reforms which are on the table (and conforming to the requirements of the new H.S. Graduation guidelines).**
- **Working with Dr. Evans on the transition and changes of his office.**
- **Keeping vigilant about pressure from NCLB to measure students' learning solely by standardized tests, rather than using an array of challenging assessments on the quality of teaching and learning occurring in the school.**
- **Allowing innovations by staff and community that increase student learning.**

How many School Board meetings have you attended during the last year? What has been your experience?

One.

I noticed that much of the detail work of the Board is done ahead of time, and that members are required to read, consider issues, and be ready to vote on the smaller ones, before the meeting starts.

In addition, as new initiatives are being discussed, Board members' diverse perspectives are key to balancing the needs of the community and of the district office.

I would also like to note that I have been to many school board meetings for communities I lived in over the last 30 years.

Please describe why you are interested in serving as a school board member; what are the strengths and experience that you will bring to this position?

I am interested in running for this position because the School Board has a crucial, yet finite, role in managing a school district, and I think that my personal and professional experiences have given me a strong background for the position.

As a public high school student, I was active in various ways to change and improve the schools. I then spent 16 years working in non-profit, and for-profit, businesses, before re-entering public schools as an employee. I have since worked for 16 years in high poverty, public schools: as a guidance counselor or project manager for grades K-12, and then as a Director of a small high school.

I am currently working with an education program for low-income young adults: the recent products of our public high schools. About a third have their GED's (which means they dropped out of high school), and the rest graduated from a range of high schools in the state's urban areas.

In these various positions, I have often been the one who did the initial read on new regulations and laws, and then met with stakeholders to determine how the school would respond (ie. create new initiatives or committees or strategies). I feel I learned the most from 1) creating School Improvement Teams, 2) leading the College Access Team at the Met (100% of graduates who apply get accepted into college), and 3) serving on RIDE's Graduation by Proficiency Guidelines Steering Committee.

My strengths are an ability to listen, to work hard, to be comfortable in diverse situations, and a love of finding win-win solutions to problems. My skills are a comfort with legal language, writing grants and policies, managing a team, and conflict mediation.

Please describe your experience, strengths and skills working with youth, public schools, civic programs, or as a parent.

I co-founded the Leominster Youth Center when I was 14, and have been involved in civic or school initiatives ever since. As you can see from my resume, I have worked for (or run) a community newspaper, a political campaign, and on various Advisory Boards (all unpaid). I also have been involved in Save the Bay, and support youth groups, social services, and timely issues like voter registration or neighborhood clean-ups.

There is no other volunteer job, though, that is more important or all-consuming, than being a parent. That perspective has allowed me to help create family-friendly programs in elementary, middle and high schools. Schools should be a place that welcomes, listens to, and involves families in meaningful ways.




