
Dear Ms. Testa:

Within the past two weeks East George Street has been paved and construction is nearly completed. Enclosed find your letter dated June 18, 1991 confirming that East George Street was established that it would be an one-way street in an easterly direction from Gano Street to Wayland Avenue. Kindly insure that traffic signs and traffic controls, with respect to the one-way, are put in place in the near future. The absence of traffic controls has created a hazardous condition for motor vehicle operators. Any assistance that you can provide concerning this matter is greatly appreciated. Lastly, a placement of a traffic light at the intersection of Wayland Avenue and new completed section of East George Street may be necessary. This will avoid increased traffic traveling from Gano Street through East George Street and will also allow for motor vehicle operators on East George Street access on to Pitman Street.




