Resolved, DECREED AND ORDERED,

That Sovereign Street from South Main Street to South Water Street, shown as shaded area and designated by the letters A-B-C-D on the accompanying plan entitled "Providence, R.I., P.W. Dept. - Engineering Office, City Property Section, Plan No. 061243, Date July 18, 1955", has ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, that the Superintendent of Street Signs and Numbers be and he is hereby directed to cause a sign to be placed at each end of Sovereign Street, abandoned as aforesaid, having thereon the words "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree, the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence, at least once each week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting upon said Sovereign Street, which has been abandoned, who is known to reside within this State.



Dear Sir:

Sovereign Street from South Main Street to the Harbor Line is classified as a received street, the date of reception being given as May 1, 1746 and the authority being the Proprietor's Plat which is recorded on plat card 117 in the Office of the Recorder of Deeds.

The section of Sovereign Street from South Water Street to the Harbor Line is in the line of the North South Freeway.

The section of Sovereign Street from South Main Street to South Water Street has the same status as several other narrow streets which extend from South Main Street to South Water Street.

We do not know of any good reason for the abandonment and recommend that the petition be held until such time as final plans are completed for the construction of the section of the Freeway between Crawford and Point Streets

SUBJECT: REFERRAL NO. 722 - ABANDONMENT OF SOVEREIGN STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, August 23, 1955.

This referral is a request for the abandonment of Sovereign Street from South Main Street to South Water Street. Properties on both sides of this section of the street are in one ownership, and it is understood that the proposed use of the street area is for parking.


On the field trip it was found that the area in question is a narrow 12-foot cobble-stone street.

Inasmuch as there are in this area a number of streets with similar status where abandonment might be requested,

The Commission

VOTED: To recommend that the petition be tabled, without prejudice, pending a determination of need for access between South Main and South Water Streets when the freeway is completed.



the following named person, firm or corporation is hereby granted permission to erect, alter or use a building or structure at the location named herein for the sale of petroleum, kerosene, gasoline, coal oil and their products, compounds and components as described and shown in and on the application therefor and accompanying plat, all on file in the office of the Inspector of Buildings subject to the conditions that said person, firm or corporation shall not violate any of the laws of the State of Rhode Island or any of the Ordinances of the City of Providence relative to the erection, use or occupation of said structure and that said person, firm or corporation shall not allow petroleum, kerosene, gasoline, coal oil or their products, compounds or components, to be conveyed over or across any sidewalk by means of any pipe or hose, and upon such special conditions as are hereby enumerated, viz:

Ward 4: Gulf Oil Corporation, 2 Randall Street, Plat 2, Lots 288 and 262, remove 5-1,000 gallon gasoline storage tanks and install 2-3,000 and 2-4,000 gallon gasoline storage tanks, making a total storage capacity of 15,000 gallons upon the premises.

At a meeting of the Zoning Board of Review held on Tuesday, September 25, 1956, the following resolution was adopted:

WHEREAS, Leon T. Petit and wife Sarah, owners of Lots 60 and 632 on Assessor's Flat 70 on the southeasterly corner of Douglas Avenue and Donaldson Street and the southerly side of Donaldson Street next to the corner of Douglas Avenue (391 Douglas Avenue) in a Commercial C-4 Zone, on July 23, 1956, filed an application for permission to install an underground tank for the storage of 5,000 gallons of gasoline making a total underground storage capacity of 13,000 gallons, and

WHEREAS, a public hearing was held on this application by the Zoning Board of Review at its meeting held on Tuesday, September 25, 1956, after public notice as provided by the Zoning Ordinance,

RESOLVED: That the Zoning Board of Review does hereby make a variation of the use district regulations under the Zoning Ordinance and does hereby grant the application of Leon T.
