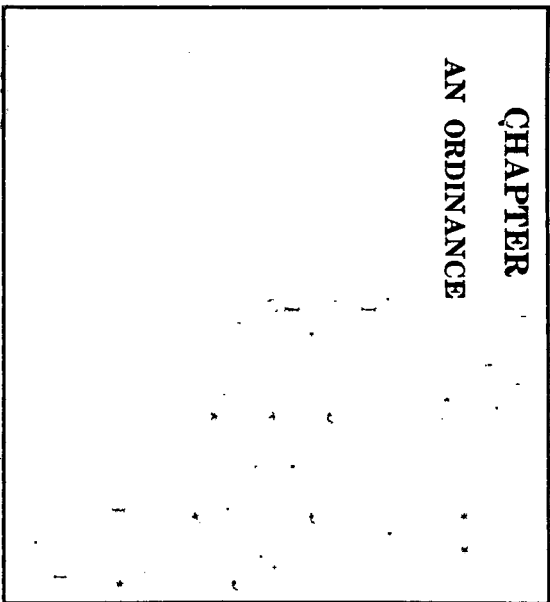

Approved January 18, 1957

WHEREAS, during the deliberations by the several succeeding Committees on Ordinances of the City Council, Mr. Addeo, by his reservoir of knowledge, proved invaluable,

NOW, THEREFORE, BE IT RESOLVED, that this City Council does hereby dedicate in his memory, that Building Ordinance of the City of Providence, approved December 21, 1956, and further directs the City Clerk to cause the following paragraph to be incorporated in all future publications and printings of this Ordinance:

"Dedicated to the late Alexander Addeo, Inspector of Buildings from May 2, 1932, to March 23, 1956, and Secretary of the Building Code Revision Committee, whose knowledge, experience and vision were instrumental in the formulation of this Code."
