CHAPTER 68-38

No. 182 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1870, BY APPROPRIATING THE SUM OF SIXTY TWO THOUSAND FIVE HUNDRED (\$62,500) DOLLARS to CONTINGENCIES APPROPRIATION, ITEM 3.

Approved April 19, 1968

Be it ordained by the City of Providence:

SECTION 1. Chapter 1870 of the Ordinances of the City of Providence, as approved September 25, 1967, and entitled: "An Ordinance Making Appropriation of \$50,670,558.30 for the Support of the City Government for the Fiscal Year Ending September 30, 1968", as amended, is hereby further amended by appropriating the sum of Sixty Two Thousand Five Hundred (\$62,500) Dollars to CONTINGENCIES APPROPRIATION, ITEM 3.

SECTION 2. The said sum of Sixty Two Thousand Five Hundred (\$62,500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Sixty Two Thousand Five Hundred (\$62,500) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.


