Section 1. Chapter 1972-32 of the Ordinances of the City of Providence as approved June 23, 1972, and entitled: "An Ordinance Making Appropriation of \$76,070,746.51 for the Support of the City Government for the Fiscal Year Ending June 30, 1973", is hereby further amended by transferring certain sums of money within the various departments as follows:

Section 1. Chapter 1972-32 of the Ordinances of the City of Providence, as approved June 23, 1972, entitled: "An Ordinance Making Appropriation of \$76,070,746.51 for the Support of the City Government for the Fiscal Year Beginning July 1, 1972 and Ending June 30, 1973", as amended, is hereby further amended by appropriating the sum of Thirty Five Thousand Dollars (\$35,000) to Contingencies, Item 1.

Section 2. The said sum of Thirty Five Thousand Dollars (\$35,000) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer Thirty Five Thousand Dollars (\$35,000) from the Reserve for Extraordinary Expenditures Account to the Receipt Account.
