

RESOLUTION OF THE CITY COUNCIL

No. 537

Approved October 15, 1996

RESOLVED, That the Traffic Engineer is requested to prohibit motor vehicle traffic along various streets located in the vicinity of the East Side of Providence of Brown University beginning on Saturday, September 21, 1996, between the hours of 6:30 o'clock A.M. and 6:30 o'clock P.M. to accommodate Football Season, as follows:

Suggested Traffic Regulations:

One Way Traffic:

- Sessions Street - One way easterly from Morris Avenue to Taft Avenue
- Taft Avenue - One way northerly from Sessions Street to Savoy Street

No Traffic:

- Between Taft Avenue and Elmgrove Avenue
- Sessions Street - Between Taft Avenue and Elmgrove Avenue
- Taber Avenue - Between Emeline Street and Sessions Street

No Parking:

- Aldrich Terrace - Either side
- Savoy Street - Either side between Hope Street and Elmgrove Avenue
- Taft Avenue - Either side between Sessions Street and Savoy Street
- Morris Avenue - Either side between Sessions Street and Emeline Street
- Taber Avenue - Either side between Sessions Street and Emeline Street
- Stadium Road - Either side between Sessions Street and Emeline Street
- Sessions Street - Either side between Morris Avenue and Elmgrove Avenue
- Elmway Street - Either side
- Doyle Avenue - One side: between Taber Avenue and Elmgrove Avenue
- Upton Avenue - One side: Elmgrove Avenue and Wayland Avenue

- Taber Avenue - Between Emeline and Sessions Street



Seven officers plus one supervisor have been requested; detail should report to the press room at the stadium two hours before game time for assignments to the following posts:

- 1) One officer assigned to each ticket booth area (three total). These officers stay in place monitoring the entering crowd for alcohol and watching over the ticket receipts. They should stay in place until Tom Bold or his designee relieves the ticket sellers and closes the gate. One ticket booth on each side will remain open until five minutes into the second half of each game. Officers working the ticket booth may be relieved at half-time or when the ticket booth closes; however, in the event a need arises, Supervisor on duty shall make a decision to secure these officers or have them remain on duty.
- 2) Two officers should be assigned to each of the two parking lots. They should be in place 1.5 hours before game time. Five minutes before game time, they should begin to encourage people to clear the parking lots. At game time, the parking lots are closed. The officers should encourage people to move into the game and then take positions one at each end of the two gates onto the track in the middle of each stand and one at the end of each stand on the tract at the flag pole end of the field. These officers should support the ushers in controlling traffic and should monitor the crowd for inappropriate behavior.
- 3) During the game, the officers not at ticket booths should be stationed as follows:
 - a) The gate to the Brown locker room.
 - b) The gate to the visiting team locker room.
 - c) The side of the visiting team stands near the flagpole.
 - d) The gate near the bell.
 - e) The Sergeant rooms.
- 4) At least once per quarter, an officer should walk each of the aisles to check for alcohol.

- 5) Some points of clarification:
- a) Fans can go on the field after the game when it is clear that no problems will erupt from the teams.
 - b) Fans may walk around the flagpole from one side to the other during the game, but they cannot watch the game from there.
 - c) No one touches the bell other than the assigned team.

Brown EMS:

On duty Brown University Emergency Medical Services personnel will be on site at each game from 1230 - 1630. Red Cross personnel will also be present.





Seven officers plus one supervisor have been requested; detail should report to the press room at the stadium two hours before game time for assignments to the following posts:

- 1) One officer assigned to each ticket booth area (three total). These officers stay in place monitoring the entering crowd for alcohol and watching over the ticket receipts. They should stay in place until Tom Bold or his designee relieves the ticket sellers and closes the gate. One ticket booth on each side will remain open until five minutes into the second half of each game. Officers working the ticket booth may be relieved at half-time or when the ticket booth closes; however, in the event a need arises, Supervisor on duty shall make a decision to secure these officers or have them remain on duty.
- 2) Two officers should be assigned to each of the two parking lots. They should be in place 1.5 hours before game time. Five minutes before game time, they should begin to encourage people to clear the parking lots. At game time, the parking lots are closed. The officers should encourage people to move into the game and then take positions one at each end of the two gates onto the track in the middle of each stand and one at the end of each stand on the tract at the flag pole end of the field. These officers should support the ushers in controlling traffic and should monitor the crowd for inappropriate behavior.
- 3) During the game, the officers not at ticket booths should be stationed as follows:
 - a) The gate to the Brown locker room.
 - b) The gate to the visiting team locker room.
 - c) The side of the visiting team stands near the flagpole.
 - d) The gate near the bell.
 - e) The Sergeant roams.
- 4) At least once per quarter, an officer should walk each of the aisles to check for alcohol.
