An Ordinance Amending Section 10 of Chapter 1973-30, Approved June 25, 1973, Entitled: "An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments."

Section 1. Section 10 of Chapter 1973-30 of the Ordinances of the City of Providence, approved June 25, 1973, is hereby further amended as follows:

Section 10. City Collector's Division

The number of employees in the *City Collector's Division* shall not exceed nineteen (19). There shall be no more than:

Eliminate: One (1) Clerk III

Sec. 2. This Ordinance shall take effect upon its passage.
