An Ordinance Amending Section 4-37 (a) of the Code of Ordinances of the City of Providence Relative to Certain Types of Dogs, by Creating Sections 4-53, 4-54 and 4-55 of Said Code, as Amended.

An Ordinance in Amendment of and In Addition to Article II, Entitled: "Dogs" of the Code of Ordinances of the City of Providence by Adding Section 4-27, to be Entitled: "Canine Waste and its Removal", as Amended.

Be It Ordained by the City of Providence:

Severally Read and Collectively Passed, the First Time, on motion of COUNCILMAN ADDISON, seconded by COUNCILMAN GLAVIN by the following Roll Call Vote:

Section 1. Article II of the Code of Ordinances of the City of Providence, entitled: "Dogs" is hereby amended by adding Section 4-27, to read as follows:

Ayes: Council President Fagnoli and Councilmen Addison, Almagno, Councilwoman Brassil, Councilmen Cirelli, Easton, Farmer, Glavin, Griffin, Johnson, Lynch, Mansolillo, Moise, O'Connor, Paolino, Pen-nine, Petrosinelli, Salvatore and Xavier—19.

Section 4-27. Canine Waste and its Removal

Nays: Councilman Snowden—1.

(a) *Duties To Dispose* It shall be the duty of each person who owns, possesses or controls a dog to remove and dispose of any feces left by his/her dog on any sidewalk, street or other public area. It shall further be the duty of each person who owns, possesses or controls a dog to remove and dispose of any feces left by his/her dog on any private property neither owned nor occupied by said person.

Absent: Councilmen Boyle, Cola, Dillon, Flynn, Pearlman and Stravato—6.

The motion for Passage the First Time, is Sustained.

(b) *Duty To Possess Means Of Removal* No person who owns, possesses or controls such dog shall appear with such dog on any sidewalk, street, park or other public area without the means of removal of any feces left by such dog. Further more, no person who owns, possesses or controls such dog shall appear on any private property neither owned nor occupied by said person without the means of removal of any feces left by said dog.

The following Ordinance was in City

(c) *Method Of Removal And Disposal* For the purpose of this regulation, the means of removal shall be any tool, implement, or other device carried for the purpose of picking up and containing such feces, unexposed to said person or the public. Disposal shall be accomplished by transporting such feces to a place suitable and regularly reserved for the disposal of human feces to a place specifically reserved for the disposal of canine feces, or to a place so designated as appropriate by the Department of Public Works.

(d) *Fines For Violation* Violation of this regulation shall be punishable by a fine not exceeding Ten Dollars (\$10.00) for the first offense, not exceeding Fifteen Dollars (\$15.00) for the second offense within a year, not exceeding Twenty-Five Dollars (\$25.00) for the third and any subsequent offenses within a year to be recovered by action of debt or by complaint or warrant, to use as such City Council may prescribe.

(e) *Exemption* This regulation shall not apply to a licensed dog accompanying any handicapped person who, by reason of his/her handicap, is physically unable to comply with the requirements of this ordinance.

(f) *Severability* The Provisions of this section are severable and if any of the Provisions of this section shall be held unconstitutional or in conflict with any other section of the City Charter

or Ordinances of the City of Providence or State Law, then such section shall be void without affecting or impairing any of the remaining Provisions.

Section 2. This Ordinance shall take effect upon its Passage and approval by the Mayor.

created and existing under the laws of the State of Rhode Island, of a tract of land situated at a portion of Assessor's Plat No. 56, Lot No. 28, containing approximately 355,660 square feet at an annual rental of eleven cents (\$.11) per square foot for a total annual rental of thirty-nine thousand, one hundred twenty-two dollars and sixty cents (\$39,122.60) for a ten (10) year period with two (2) successive options to renew for terms of five (5) years each; the rates of rental of each option period to be negotiated by the Committee
