
Approved November 28, 1989

RESOLVED, That the City of Providence, by and through its Mayor, Joseph R. Paolino, Jr., is hereby authorized to transfer a certain parcel of land, designated as a portion of Collyer Park; on Collyer Street, also known as Lot 4, on Assessor's Plat 75. Said parcel, being more or less 58,672 square feet and more fully described in Attachment A, is to be transferred to the Providence Redevelopment Agency for disposition under such terms as may be approved by His Honor the Mayor and the City Solicitor, and





Dear Rose:

The proposed transfer of land has been requested by the Department of Planning and Development. Your August 2, 1989 request for additional information was forwarded to Mr. John Palmieri of DPD. Mr. Palmieri has been in frequent contact with Councilman Annaldo on this matter.

The land proposed for transfer is surplus park land. The Board of Park Commissioners voted in October, 1988 to transfer the land to the Providence Redevelopment Authority for disposition with certain restrictions, namely that houses on Collyer Street be screened from the proposed parking lot by adequate landscaping and that lighting be designed so as not to spill over on to residential property.

If you have additional questions, I would be glad to meet with Committee on City Property.

Suggested Property Description

PROVIDENCE REDEVELOPMENT AGENCY

That certain tract or parcel of land, with all buildings and improvements thereon, situated on the southwesterly side of Smithfield Avenue and the northwesterly side of Collyer Street in the City of Providence, County of Providence, State of Rhode Island and Providence Plantations being bounded and described as follows:

Beginning at the point of intersection of the existing northwesterly City Street Line of Collyer Street and the existing southwesterly State Freeway Line of Smithfield Avenue, said State Freeway Line as established by State Highway Plat No. 1375 as filed in the office of the City Clerk of Providence, said point being at the northeasterly corner of land now or formerly belonging to the City of Providence, said point also being the northeasterly corner of the herein described parcel;

Thence northwesterly, along the said southwesterly State Freeway Line of Smithfield Avenue as established by said State Highway Plat No. 1375, a distance of one hundred eighty and fifty five one-hundredths (180.55) feet to a point on the centerline of the Moshassuck River as relocated in 1916, said point being on the existing southeasterly property line of land now or formerly belonging to Bonanza Bus Lines, Inc., said point also being at the beginning of a curve;

Thence southwesterly, bearing westerly along the said centerline of the Moshassuck River and bounded northwesterly by the said Bonanza Bus Lines, Inc., land, along the arc of a curve having a radius of one thousand and no one-hundredths (1000.00) feet and subtended by a central angle of $190^{\circ}15'05''$, an arc distance of three hundred thirty six and no one-hundredths (336.00) feet to the end of said curve, the chord of said curve forming an interior angle of $97^{\circ}00'16''$ with the last above described course;

Thence southeasterly, radial to the above described curve and across the aforesaid City of Providence land, a distance of fifty and no one-hundredths (50.00) feet to the beginning of another curve;

Thence easterly, bearing southeasterly across the said City of Providence land and along the arc of a curve having a radius of one hundred sixty and no one-hundredths (160.00) feet and subtended by a central angle of $45^{\circ}22'22''$, and arc distance of one hundred twenty six and seventy one-hundredths (126.70) feet

to the end of said curve, the chord of said curve forming an interior angle of $127^{\circ}43'58''$ with the last above described course;

Thence southeasterly, across the said City of Providence land, a distance of fifty nine and thirty three one-hundredths (59.33) feet to a point;

Thence turning an interior angle of $90^{\circ}00'00''$ and running northeasterly, across the said City of Providence land, a distance of fifty six and no one-hundredths (56.00) feet to a point;



Thence turning an interior angle of $270^{\circ}00'00''$ and running southeasterly, across the said City of Providence land, a distance of seventy and no one-hundredths (70.00) feet to a point on the aforesaid northwesterly City Street Line of Collyer Street;

Thence turning an interior angle of $91^{\circ}00'00''$ and running northeasterly, along the said northwesterly City Street Line of Collyer Street, a distance of one hundred ninety four and ninety nine one-hundredths (194.99) feet to the place of beginning.

The last described course forms an interior angle of $101^{\circ}57'02''$ with the first above described course.

The herein described parcel contains fifty eight thousand six hundred seventy two (58,672) square feet or 1.3469 Acres of land.
