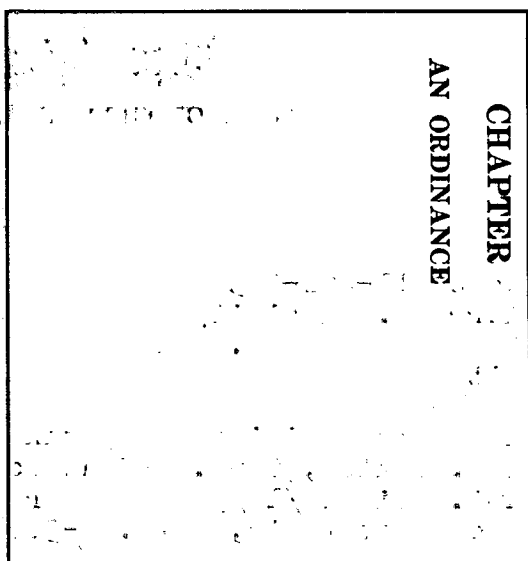

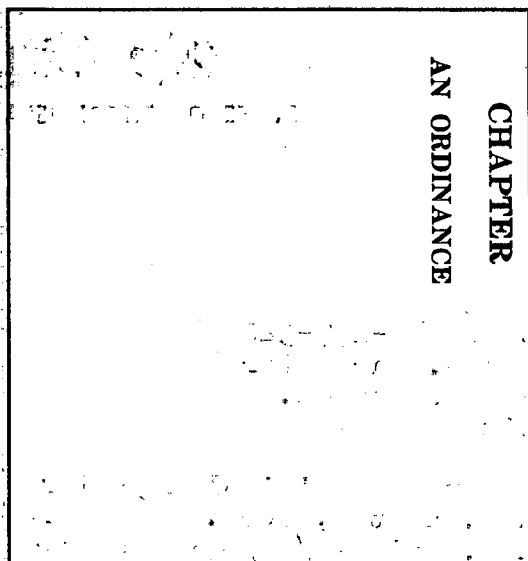

Whereas,

it appears that the valuation of the ratable property of the City of Providence fixed by the Tax Assessor as of December 31, 1955, will not yield the amount of tax to be legally ordered by the City Council and to be levied for the purposes authorized by law excluding any amount required to pay the indebtedness of the City;

NOW, THEREFORE, BE IT RESOLVED That His Honor, the Mayor, and the Finance Director, are hereby authorized to petition the Director of the Department of Administration of the State of Rhode Island under the provisions of Section 28 of Chapter 329, General Laws of Rhode Island, 1938, as amended, to authorize a tax assessment to be made by the City Council of the City of Providence in excess of the $2\frac{1}{2}\%$ (two and one-half percent) of the value of the ratable property of the City, and to present to said Director of the Department of Administration, State of Rhode Island, such evidence as may be necessary with respect to the merits of this petition.
