- 1-1 SECTION 1. Section 45-2-15 of the General Laws in Chapter 45-2 entitled "General

 1-3 **45-2-15. Police officers and fire fighters.** -- No city or town shall require that an
 1-4 individual reside within the city or town as a condition for appointment or continued employment
 1-5 in its police or fire department; ~~provided, that the provisions of this section shall not apply to the~~

 1-7 SECTION 2. This act shall take effect upon passage.



It is enacted by the General Assembly as follows:

- 1-1 SECTION 1. Chapter 31-22 of the General Laws entitled "Miscellaneous Rules" is
1-2 hereby amended by adding thereto the following section:
- 1-3 31-22-11.9. School bus idling. – The operator of any school bus shall not operate the
1-4 engine of any school bus for more than three (3) consecutive minutes when the school bus is not
1-5 in motion except:
- 1-6 (1) when the school bus is forced to remain motionless because of traffic conditions or
1-7 mechanical difficulties over which the operator has no control;
- 1-8 (2) when it is necessary to operate heating, cooling or auxiliary equipment installed on
1-9 the school bus when such equipment is necessary to accomplish the intended use of the school
1-10 bus, including, but not limited to, the operation of safety equipment;
- 1-11 (3) when the outdoor temperature is below twenty (20) degrees Fahrenheit;
- 1-12 (4) when it is necessary to maintain a safe temperature for students with special needs;
- 1-13 (5) when the school bus is being repaired; or
- 1-14 (6) when the operator is in the process of receiving or discharging passengers on a public
1-15 highway or public road.
- 1-16 SECTION 2. This act shall take effect upon passage.

- 2-1 This act would provide that the operator of a school bus shall not operate the engine of
2-2 any school bus for more than three (3) consecutive minutes when the bus is not in motion.
2-3 This act would take effect upon passage.
