





Providence Deputy City Solicitor, Charles R. Mansolillo, began his career in public service as the youngest member of the Providence delegation to the Rhode Island General Assembly in 1973. Beginning in 1975, he served the City of Providence for nearly a decade as a City Councilman and as Chief of Staff to Mayor Vincent A. Cianci, Jr. In 1979, Charles was elected a member of the Commission which authored the Providence Home Rule Charter. From 1987 to 1991, Charles served successively in state government as Legal Counsel for the Department for Children and Their Families, as Director of the Governor's Office of Housing, Energy and Intergovernmental Relations, and as Policy Director for Governor Edward D. DiPrete.

Active in community affairs, he served as Chairman of the board of the Providence Community Action Program (ProCAP) and as a Trustee of the Providence Public Library. He is a lifelong communicant of the Church of the Assumption where he serves as a religious education teacher, leader of song and extraordinary minister of the Eucharist.

Charles is a member of the American and Rhode Island Bar Associations and has served on the Rhode Island Bar's Municipal Law and Environmental Law Committees. A cum laude graduate of Saint Michael's College, he received his law degree from Suffolk University Law School.






