# RESOLUTION OF THE CITY COUNCIL

No. 241

Approved April 13, 2011

WHEREAS, On February 21, 2007, through Resolution # 121, the Providence City Council renamed the intersection of Eaton Street and River Avenue as "Most Reverend John Fabian Cunningham, O.P. Square"; and

WHEREAS, Providence College, which heretofore has utilized the address of 549 River Avenue, Providence, RI 02918-0001, and which is located on Cunningham Square, would like to have its address changed to reflect the newly-named square, e.g. 1 Cunningham Square, which change is already reflected in the records of the Providence Tax Assessor; and

WHEREAS, The United States Postal Service prefers that any such address changes have the sanction of the Providence City Council;

NOW, THEREFORE, BE IT RESOLVED, That the address to be used for Providence College shall henceforth be 1 Cunningham Square, Providence, Rhode Island, subject to the rules and regulations of the United States Postal Service.



RE: Providence College Address Change


The Providence Fire Department has received a Memorandum from the City Clerk and a draft Resolution of the City Council for an address change for Providence College.


