## CHAPTER 1982-65

No. 652 **AN ORDINANCE** TO AUTHORIZE THE ISSUANCE OF ONE HUNDRED SIXTY THOUSAND DOLLARS (\$160,000.) PUBLIC IMPROVEMENT BONDS FOR CAPITAL IMPROVEMENTS TO THE PROVIDENCE PUBLIC LIBRARY PURSUANT TO CHAPTER 8 OF THE PUBLIC LAWS OF 1967 AND CHAPTER 181 OF THE PUBLIC LAWS OF 1981.

*Approved* December 10, 1982

*Be it ordained by the City of Providence:*

SECTION 1. The sum of One Hundred Sixty Thousand Dollars (\$160,000.) shall be borrowed for the purpose of the renovation, improvement, enlargement and relocation of existing library buildings and facilities of the Providence Public Library. The City Treasurer, with the approval of the Mayor and the Committee on Finance, is authorized to issue One Hundred Sixty Thousand Dollars (\$160,000.) Public Improvement Bonds pursuant to Chapter 8 of the Public Laws of 1967 and Chapter 181 of the Public Laws of 1971 and subject to the foregoing, to determine the denominations, interest rate or rates and other terms, conditions and details of the bonds in accordance with law.

SECTION 2. The bonds shall be issued originally as coupon bonds in substantially the form approved by the City Council in Resolution No. 63, approved February 21, 1968, with such provisions for redemption of the bonds prior to maturity, if any, as may be determined by the City Treasurer, with the approval of the Mayor and the Committee on Finance. The bonds shall be sold at public sale at not less than par and accrued interest and shall bear such date or dates as the City Council shall determine by resolution and shall be payable in annual installments commencing not later than five years and ending not later than twenty-five years from their date or dates as the City Council shall determine by resolution.

SECTION 3. This Ordinance shall take effect upon its passage and all other Ordinances or parts thereof inconsistent herewith are hereby repealed.
