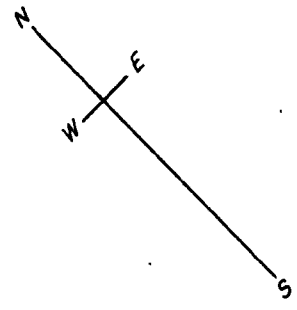

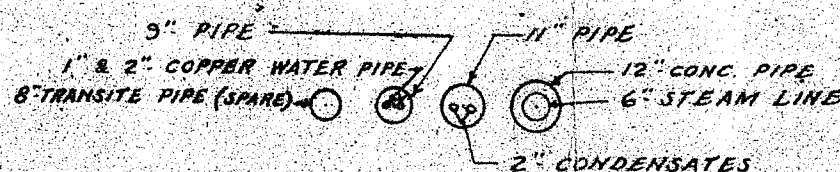


Gentlemen:

The Traffic Engineering Department has reviewed a request from the Parent-Teachers Association of the Nelson Street School to make Nelson Street, between Smith Street and Eaton Street, a one-way street. The purpose for this change is to reduce the vehicular congestion in front of the school, and also reduce the potential accident hazard to children approaching or leaving the school.

In reviewing this request the residents of this block have been consulted. A petition signed by eight individuals favoring the establishment of a one-way street has been received.

The volume of traffic using Nelson Street is not great, but is sufficient to severely congest the street at times, particularly when it is used as a two-way street. Therefore, it is recommended that Nelson Street be made a one-way street in a northerly direction between Smith Street and Eaton Street. It is further recommended that the existing "No Parking 8AM to 4PM" on the easterly side be changed to "No Parking Any Time" and that unrestricted parking be permitted on the westerly side of the street with the left side of the vehicles parallel to the left curb.
