RESOLUTION OF THE CITY COUNCIL

Approved September 30, 1977

RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF PROVIDENCE TO PREPARE AND SUBMIT AN APPLICATION(S) UNDER THE URBAN MASS TRANSPORTATION ACT OF 1964 (P.L. 88-365), AS AMENDED. --(SECTION 6)

WHEREAS, the Urban Mass Transportation Act of 1964 (P.L. 88-365), as amended, authorizes the Secretary of Transportation to make grants to demonstrate new facilities, equipment, techniques and methods in an operational environment that will reduce urban transportation problems and improve mass transportation service; and

WHEREAS, the City of Providence deems it necessary and in the public interest (1) to undertake specific projects within the definition of mass transportation service in urban areas and (2) to cooperate with the Rhode Island Public Transit Authority in providing for an efficient and coordinated mass transportation system; and

WHEREAS, the City of Providence, in order to obtain such grants must assure and certify that it shall comply with all the regulations, policies, guidelines and requirements for the acceptance and use of federal funds and gives assurance and certifies it will comply in particular with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder and other assurances as required under application procedures of the U.S. Department of Transportation.

NOW, THEREFORE, BE IT RESOLVED by the CITY COUNCIL OF THE CITY OF PROVIDENCE as follows:

1. That the Mayor of the City of Providence is hereby authorized and designated as the representative of the

City for the filing of application(s) with the U.S. Department of Transportation, to aid in the financing of the Kennedy Plaza Transit and Pedestrian Improvement Project consisting of non-capital elements proposed for UMTA Demonstration Grant (Section 6).

2. That the Mayor of the City of Providence is authorized to execute and file with such application all assurances or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964 and to do and cause to be done, all the work necessary to carry out the terms of any contract between the City and the U.S. Department of Transportation arising out of said application(s) for such grant.

3. That, the Director of the Department of Planning and Urban Development is authorized to furnish such additional information as the U.S. Department of Transportation may require and is further authorized to administer the project on behalf of the City of Providence.
