RESOLUTION OF THE CITY COUNCIL

Approved December 24, 1985

RESOLVED, DECREED AND ORDERED:

That the following named street shown as cross-hatched area on the accompanying plan entitled, "Providence, Rhode Island, Department of Public Works - Engineering Office, Street Line Section Plan No. 064334, dated October 29, 1985",

VIZ:

Tingley Street, (portion of) in its entire width between the westerly line of Charlotte Hope Street and the westerly line of its west terminus, shown as cross-hatched area on accompanying plan and designated by the letters (A-B-C-D-A) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway, and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Director of Public Works be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.



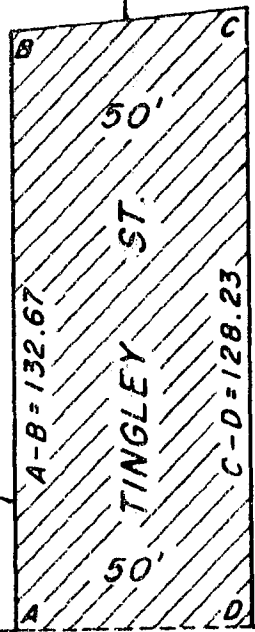

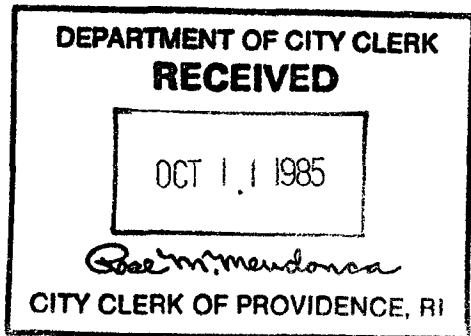
PETITION TO THE CITY COUNCIL

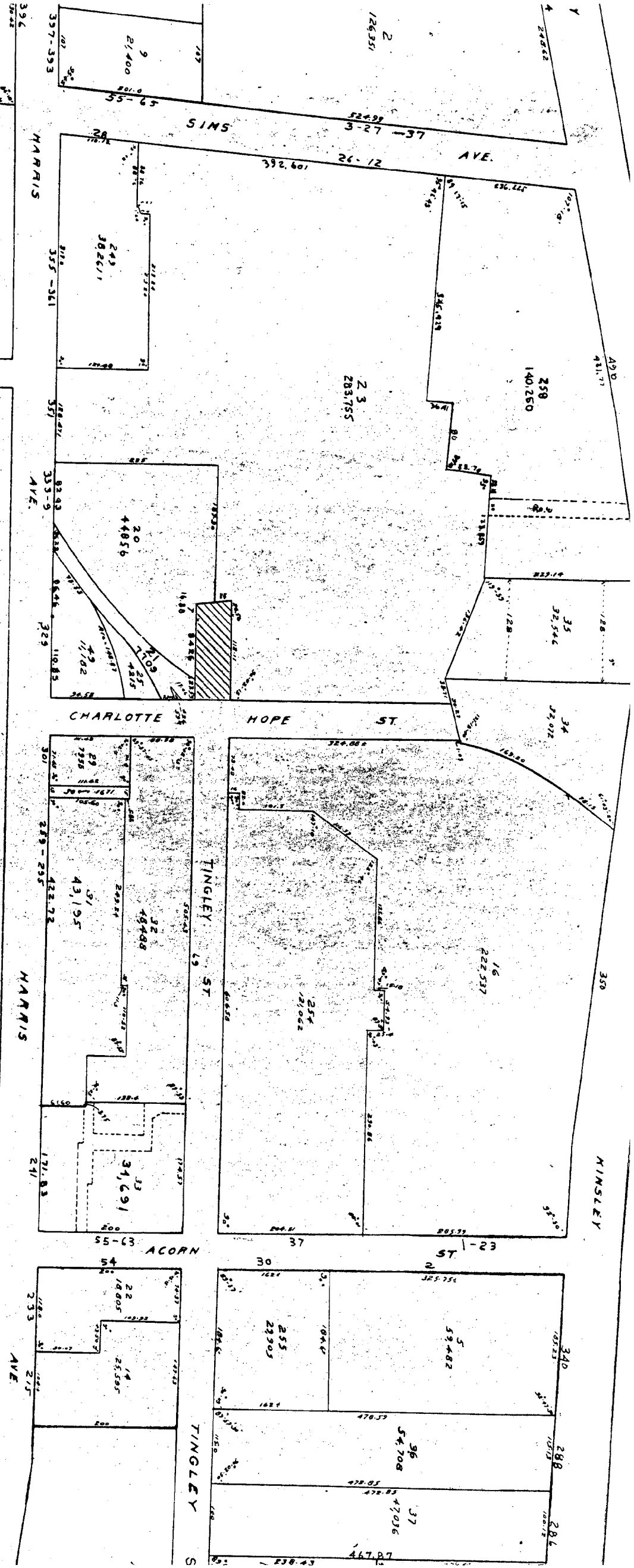

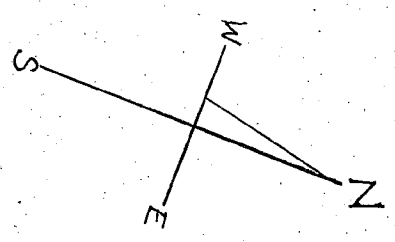
PROPOSED ABANDONMENT

Gentlemen:

The City Plan Commission at its November 5, 1985 regular monthly meeting reviewed and evaluated the subject referral from your Committee.

A communication was received from the Committee on Public Works dated October 23, 1985 requesting the City Plan Commission's recommendations on the proposed aforesaid abandonment of Tingley Street.

The petitioner is Mr. Robert C. Laurelli of 333 Harris Avenue, Providence, Rhode Island, owner of adjacent Lots 20, 25 and 26 on A.P. 27.

A field inspection revealed that aforesaid portion of Tingley Street is only a paper street. An area delineated by that paper street is partially vacant and overgrown with grass, partially used as a railroad easement by Licht Industries, Inc. (owners of Lot 21 and 16 on A.P. 27) and partially used as a parking lot by the petitioner and the Lig Rhode Island Inc., owners of adjacent Lot 23 on A.P. 27.

The Commission voted:

To advise the Committee on Public Works that no objection is offered to this petition.
