WHEREAS, House Bill 85-H 6240 relates to the Municipal Share of Administrative Adjudication Division Traffic Fines, and

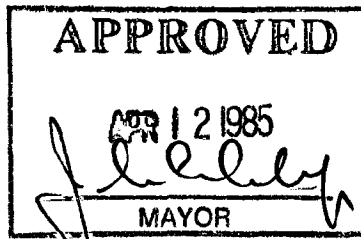
WHEREAS, Said Act increases the share of traffic fines to a municipality from Five (\$5.00) Dollars to Ten (\$10.00) Dollars,

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 31-43-5 of the General Laws in Chapter 31-43
2 entitled "Division for Administrative Adjudication" is hereby amended
3 to read as follows:

4 31-43-5. Fines and penalties -- Costs. -- An accounting of all
5 penalties and costs collected pursuant to the provisions of this chap-
6 ter shall be made to the department of administration in accordance
7 with the rules and regulations adopted by said department.

8 Provided, however, a city or town police department enforcing any
9 motor vehicle violation contained in this chapter and in chapter 41 of
10 this title shall receive five ten dollars ~~(\$5-00)~~ (\$10.00) from any
11 fine imposed for the use of said city or town.
