Honorable Gentlemen:

I have the honor to submit, in compliance with the wishes of your Honorable Body, a brief comment on the proposed resolution "that the Commissioner of Public Safety be requested to rescind the prohibition against smoking by members of the Police Department while in uniform and on duty in patrol cars."

The proposed resolution refers to Rule X, "Conduct and Department, General Provisions," Section 33, to wit:

A member of the force shall not, while in uniform and in a public place or department vehicle, smoke, chew or eat anything.

This rule has been in force for many years, and is regarded by police superiors as basic - much the same as obedience, promptness, neatness, and alertness in carrying out the responsibilities of a police officer.

The relaxing of this regulation has been proposed before, but the considered judgement of the administrative superiors in each instance was that the best interests of the department as a whole required retention of the rule.

It is pretty generally agreed among police administrators throughout the country, and probably by the general public, that relaxing rules such as this might possibly create an image of a casual and not particularly alert police department.

I respectfully request your Honorable Body to forego action on this resolution at the present time.

Honorable Gentlemen:

I have the honor to submit, in compliance with the wishes of your Honorable Body, a brief comment on the proposed resolution, "that the Commissioner of Public Safety be requested to consider a police cadet program of clerical positions in the police department for prospective police trainees."

Police Cadet Programs now exist in more than a score of cities throughout the country with exceptionally fine programs in Milwaukee and Cincinnati. More than two years ago, studies were made in this department as to the feasibility of such a program in Providence. These studies indicate that a Cadet Program could be successfully operated. Other members of your Honorable Body, among them Mr. O'Connor and Mr. Wexler, have discussed this same matter with the Commissioner at various times during the last two years.

The program has not been launched yet because several other programs of higher priority had to be undertaken ahead of the Cadet Program. All of these were directly connected with crime reduction and actual law enforcement operations. With the successful implementation of these priority programs, we will be in a good position to inaugurate a Cadet Program in the not too distant future.

Gentlemen:

Persuant to the Resolution of Mr. Prete, requesting the Superintendent of Health to consider the feasibility of acquiring a Mobile Unit for the purpose of dispensing Polio immunizations, which Resolution was referred to the Superintendent of Health, I respectfully wish to report as follows: Two years ago, the Department purchased a Hypospray Injector from the R. P. Scherer Corporation and in addition was allotted one Hypospray Injector by the State Department of Health. The latter was one of the two given to the State Health Department by the local citizenry through the Providence Journal. These units are mobile, depending upon ordinary electrical receptacles only, for use.

This Department in cooperation with the School Department, conducted three Clinics at each of the City Junior High Schools and at the Fox Point Elementary School during the months of March, April and May. The schedule was well advertised thru the School Department and the Parochial Schools as well as receiving newspaper, radio and television publicity. Approximately one thousand were immunized in March, three thousand in April and more than six thousand in May. For the month of June nine other evening clinics were set up to cover the City. These have been primarily at the Housing Projects and at Settlement areas. In addition, afternoon Clinics were held at the Federal Hill House, Nickerson House, Salvation Army, John Hope Center as well as at the Charles V. Chapin Hospital.

In addition to the vaccine supplied this department by the State Department of Health, three hundred vials of Polio Vaccine had to be purchased by the City when the State supply was not available.

I wish to take this opportunity to thank your Honorable Board for the cooperation extended this department and trust that next year you will increase your efforts to notify your constituents of the availability of the Clinics in their locality. Please stress the individual responsibility for the maintenance of immunity and that, while the City does maintain Clinics, with no question as to ability to pay, the family Physician is always ready and willing to assist his own patients in maintaining their immunity, not only to Polio but as regards all diseases, such as diphtheria, tetanus and typhoid.






