Whereas,

R E S O L V E D, T H A T The Board of Contract and Supply is hereby authorized to purchase from The Interstate Busses Corporation, a Massachusetts corporation, that certain garage building and the land appurtenant thereto, known as 144 Sabin Street, in the City of Providence, and bounded and described as follows:

Beginning at a point in the southerly line of Sabin Street, said point being 39.7 feet southwesterly from the southerly corner of Sabin Street and Greenman Lane; thence running southwesterly, bounded northwesterly by Sabin Street, 46 feet, more or less, to Cope Street; thence turning an interior angle and running southeasterly, bounded southwesterly by Cope Street, 107 feet, more or less, to land now or formerly of Rose C. Carlotti and Virginia Hanley; thence turning an interior angle and running northeasterly, bounded southerly by said Carlotti and Hanley land, 46 feet, more or less, to other land now or formerly of said Rose C. Carlotti and Virginia Hanley; thence turning an interior angle and running northwesterly, bounded northeasterly in part by said Carlotti and Hanley land and in part by land now or formerly of Morris J. and Helen H. Fishbein and Sol and Nettie Wald, 107 feet, more or less, to Sabin Street and the point of beginning and contains 4924 square feet of land, more or less. Said property is further known as Lot 112 on Plat 25 of the City Assessor's Plats of Providence, R. I.

BE IT FURTHER RESOLVED, that said sum of thirty-three thousand two hundred fifty (\$33,250) dollars be paid from the Contingency Account heretofore appropriated, the City to assume taxes assessed December 31, 1954.
