No. <sup>3</sup> **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1979-26 OF THE ORDINANCE OF THE CITY OF PROVIDENCE, APPROVED JUNE 22, 1979 AND ENTITLED, "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE WEST END PROJECT" FOR ADDITIONAL ACQUISITION.

### *Be it ordained by the City of Providence:*

1. That Chapter 1979-26 of the Ordinance of the City of Providence, approved June 22, 1979 and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the West End Project" as amended by the following Ordinances of the City of Providence: Chapter 1986-39 (June 26, 1986); Chapter 1988-32 (July 24, 1988); Chapter 1990-22 (November 5, 1990); Chapter 1994-57 (December 27, 1994) and Chapter 1996-40 October 22, 1996 is hereby further amended as follows:
