ORDINANCE CHAPTER 1974-19, APPROVED JUNE 19, 1974, BY

SECTION 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 entitled: "An Ordinance Making Appropriation of \$85,823,307.71 for the support of the City Government for the Fiscal Period beginning July 1, 1974 and ending June 30, 1975", as amended by transferring certain sums of money within certain departments.
