The Traffic Engineering Department has reviewed the petitions submitted for abandoning portions of certain streets and has approved the abandonment of the following listed streets:


On November 21, 1979 this department received from the City Clerk a memorandum and a copy of petition to abandon as a public highway Clarke Street.

In this portion to be abandoned we have a 6-inch C.I. water main and four (4) services. This main is connected at Hylestead Street and Pavilion Avenue, forming a closed loop. Cutting off this main would create a serious condition for fire protection in this area and also degrade the water supply for this area.

Possibly an easement would be an alternate consideration.




