
Gentlemen:

At the request of a petition to the City Council, the traffic engineer has studied the advisability of installing STOP or YIELD signs at the intersection of Daniel Avenue, Ethan Street and Dorchester Avenue.

At the time that traffic volume counts were made and field investigations were taken at this location, no apparent problem existed. For the three-year period from the first of July, 1951 to the end of June, 1954, only three motor vehicle accidents have been reported at this intersection. In comparison with other locations throughout the vicinity this could be considered as an excellent accident record and not one to justify the installation of traffic control.

Therefore, we are sorry to say that the request for STOP or YIELD signs at Daniel Avenue, Ethan Street and Dorchester Avenue must be denied at this time.





Gentlemen:

At the request of Council Resolution #354, dated July 2, 1954, the traffic engineer has studied the advisability of authorizing parking on one side of Mountain Street from Bond Street to Bradford Street and on one side of Jones Street from Bond Street to Bradford Street.

Both of these streets between Bond Street and Bradford Street are only 14 feet in width and cannot support parking of vehicles on one side and still permit large vehicles such as trucks or fire apparatus to pass on the street. For this reason, we feel that a NO PARKING ANYTIME regulation is required on each side of Jones Street and Mountain Street.


