IN GENERAL ASSEMBLY

JANUARY SESSION, A. D. 1972

AN ACT

IN AMENDMENT OF AND IN ADDITION TO PUBLIC LAWS 1956, CHAPTER 3654,
SECTION 31, SECTION 32, GENERAL LAWS 1956, SECTION 45-31-12 AND
SECTION 45-31-13, ENTITLED, "Redevelopment act of 1956"

It is enacted by the General Assembly as follows:

SECTION I. Rhode Island General Laws, Section 45-31-12,
is hereby amended by adding the following at the end thereof:

" * * * The redevelopment agency in the City of Providence shall consist of the Mayor, ex officio, and seven (7) members. Five (5) of the members shall be resident electors of the City of Providence and appointed by the Mayor; and shall serve for the term designated in 45-31-13; and shall not be an elected officer or employee of the City of Providence. Two (2) members shall be members of the City Council elected by the said Council from its members to serve for a term ending the first Monday in January, A.D. 1975; and shall thereafter be elected for a term of four (4) years. The powers of such agency shall be vested in the members thereof then in office. Members shall receive their actual and necessary expenses including travel expenses and may receive such other compensation as the legislative body may prescribe."

SECTION II. Nothing herein contained shall in any way alter any other part or provision of this Chapter or any appointments heretofor made thereunder, all of which remain in full force and effect.

SECTION III. This Act shall take effect upon its passage, and all Acts or parts of Acts inconsistent herewith are hereby repealed.

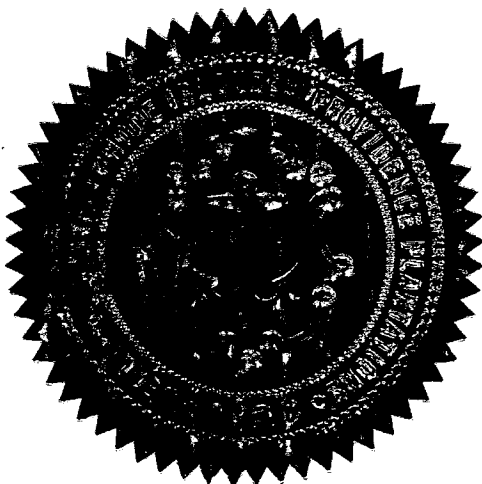
