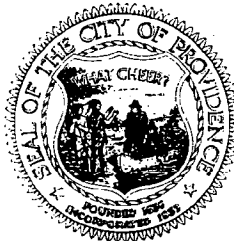

Mr. Watts' career in civil rights began in 1969 as a staff investigator for the Providence Human Relations Commission. From there he moved to the Rhode Island Commission for Human Rights and served as field supervisor for the Commission. During his 5 years of employment, Mr. Watts was involved with enforcing the equal employment and housing laws of the state of Rhode Island. In 1975 Mr. Watts accepted the position of Equal Opportunity Officer for the State of Rhode Island with the U. S. Dept. of Housing and Urban Development. Since 1978 he has been employed by the U. S. Dept. of Labor, Office of Federal Contract Compliance, involved with enforcing the laws of discrimination and compliance on the federal level with companies doing business with the federal government, as they pertain to minorities, females, handicapped workers, Vietnam Veterans and disabled veterans of other wars. Mr. Watts is a lifelong resident of Providence and is based in Rhode Island. Among the many awards received and achievements attained by Mr. Watts are:

U. S. Dept. of Housing and Urban Development  
Presented for his achievements in bringing together, for the first time, the realtors, bankers and construction companies to better fair housing, under the Voluntary Affirmative Action Program. At that time, Edward Polluck, Acting Regional Administrator, wrote that the sustained dedication displayed by Mr. Watts throughout the negotiation process, demonstrated his ability to coordinate the combined efforts of organizational elements on the federal, state and local levels.
- o That same year Mr. Watts was cited by El Mundo, Hispanic Newspaper, as the outstanding citizen involved with equal housing in the Hispanic Community.
- o Mr. Watts' involvement in the community has also included a radio program, aired weekly on WPRO, dealing with civil rights and equal housing opportunities (1976-77).
