



ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

Gentlemen:

The City Plan Commission, at its July 6, 1983 regular monthly meeting, reviewed and evaluated the subject referral which contained a request by Kevin Degnan and Charlene Degnan at 127 Michigan Avenue for the abandonment of that portion of Michigan Avenue which runs southerly from Alabama Avenue to its terminus for a distance of approximately one hundred feet. The subject portion contains approximately 4,800 sq. ft.


The Commission's comments and recommendations are as follows: -

A field inspection revealed that the subject portion is a paved right-of-way with curbs on both sides and without a sidewalk at the easterly side of the subject street. On its easterly side land slopes sharply downward about 33 ft. within a distance of approximately 70 feet. The topography of adjacent properties precludes the possibility of using the subject portion of Michigan Avenue. It appears that there are no utility lines under or above the subject portion of the street.

Therefore, the Commission

Voted: - To recommend to the Committee on Public Works that no objection is offered to this proposal.






