

ORDINANCE(S) SECOND READING

The Following Ordinances were in City Council October 4, 2018, Read and Passed the First Time and are Severally Returned for Passage the Second Time:

COUNCIL PRESIDENT SALVATORE, (By Request):

An Ordinance Amending Chapter 17, "Officers and Employees," Section 189, "Benefits Payable," of the Code of Ordinances of the City of Providence.

SECTION 1. The Code of Ordinances of the City of Providence, Chapter 17, "Officers and Employees," Section 189, "Benefits Payable," is hereby amended as follows:

Section 17-189. Benefits payable.

(a) Service retirement. Retirement of a member on a service retirement allowance shall be made by the retirement board as follows:

(1) Any member may retire upon his/her written application to the retirement board setting forth at what time, not less than thirty (30) nor more than ninety (90) days subsequent to the execution and filing thereof, he/she desires to be retired, provided that the said member at the time so specified for his/her retirement shall have attained the minimum age requirement for his/her class and notwithstanding that, during such period of notification, he/she may have separated from service. The minimum ages for service retirement for employees who became members on or before June 30, 1995 shall be as follows:

Class A employees: Fifty-five (55) or the age at which twenty-five (25) years of service is completed if prior thereto.

Class B employees: Fifty-five (55) or the age at which twenty (20) years of service is completed if prior thereto.

The minimum age for service retirement for employees who become members on or after July 1, 1995 shall be as follows:

Class A employees: Fifty-five (55) or the age at which thirty (30) years of service is completed if prior thereto.

Class B employees: Fifty-five (55) or the age at which twenty (20) years of service is completed if prior thereto.

(2) Notwithstanding anything herein to the contrary, the minimum age for service retirement for class B employees with less than (5) years of total service on the effective date of enactment of this amendment shall be fifty-five (55) or at the age at which twenty three (23) years of service.

The minimum age for service retirement for class A employees who become members on or after July 1, 2004 shall be sixty (60) years of age and have completed at least ten (10) years of total service or thirty (30) years of total service. For members that have attained age fifty-five (55) years of age and have completed at least ten (10) but not thirty (30) years of total service, the allowance on service retirement shall be reduced five-twelfths ($5/12$) percent per month for each month between retirement commencement and the age of sixty (60).

The minimum age for service retirement for class A employees who become members on or after July 1, 2009 shall be sixty-two (62) years of age and has completed at least ten (10) years of total service or thirty (30) years of total service. For members that have attained age fifty-five (55) years of age and have completed at least ten (10) but not thirty (30) years of total service, the allowance on service retirement shall be reduced five-twelfths ($5/12$) percent per month for each month between retirement commencement and the age of sixty-two (62).

This subsection (1)(b) shall not apply to members who vested with ten (10) years or more of contributing service as of June 25, 2009.

(3) Each Class B member who is a member of the police department and who has attained the age of sixty three (63) and each class B member who is a member of the police department and who attains the age of sixty-three (63), shall be retired forthwith, or on the first day of the calendar month next succeeding that in which the member shall have attained the age of sixty-three (63) years, unless said individual holds the rank of Police Chief, Deputy Police Chief, or Police Major at the time he/she has attained, or attains the age of sixty seven (67) years.

Each Class B member who is a member of the fire department and who has attained the age of sixty (60) and each class B member who is a member of the fire department and who attains the age of sixty (60), shall be retired forthwith, or on the first day of the calendar month next succession that in which the member shall have attained the age of sixty (60) years, unless said class B member of the fire department holds the rank of Fire Chief of Department at the time he/she has attained, or attains, the age of sixty-seven (67) years.

SECTION 2. This Ordinance shall take effect upon passage.

An Ordinance in Amendment to the City of Providence, "Capital Equipment Budget," As Amended, in accordance with Chapter 21, Section 19 of the Code of Ordinances.


That Ordinance Chapter 2014-16, No. 285, dated June 12, 2014 of the City of Providence shall be amended as follows:

SECTION I. The expenditure for various pool automobile purchases for the City auto fleet shall be amended to add and permit the expenditure of \$149,141.90, representing the unexpended funds previously allocated to various purchases in the original Master Lease, in accordance with the attached supporting schedules.

SECTION II. This ordinance is an affirmative action of the City Council of the City of Providence toward the issuance of the lease purchase agreement in accordance with the purposes of the laws of the State of Rhode Island. This ordinance constitutes the City's declaration of official intent pursuant to Treasury Regulation Section 1.150-2 to reimburse the City's General Fund for certain capital expenditures for the leased equipment paid on or after the date which is sixty (60) days prior to the date of this ordinance, but prior to the issuance of the lease purchase agreement. Such amounts to be reimbursed shall not exceed \$7,000,000, and shall be reimbursed not later than eighteen (18) months after (a) the date on which the expenditure is paid, or (b) the date the Project is placed in service or abandoned but in no event later than three (3) years after the date the expenditure is paid.

An Ordinance in Amendment of Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance", Approved November 24, 2014, As Amended, to change the Zoning District of Assessor's Plat 26, Lots 128, 129, 133, 139 and 143 From R-4 to C-2.

SECTION 1. Chapter 27 of the Code of Ordinances of the City of Providence, Entitled: "The City of Providence Zoning Ordinance", Approved November 24, 2014, As Amended, is hereby further amended by changing the Zoning District of Assessor's Plat 26, Lots 128, 129, 133, 139 and 143 From R-4 to C-2, as shown on the attached map.



SECTION 2. This ordinance shall take effect upon passage.

Resolution Urging the Rhode Island General Assembly to pass legislation requiring registration of all firearms.

WHEREAS, Currently, there exists no law in the State of Rhode Island requiring the registration of firearms at purchase; and

WHEREAS, The only time firearms are required to be registered are if it is a weapon used in a crime of violence or the owner has been convicted of a crime of violence; and

WHEREAS, Requiring registration only after a crime has been committed slows down the police's investigation process; and

WHEREAS, Additionally, it makes it harder to track firearms and keep them out of the streets and out of the hands of criminals; and

WHEREAS, Registering firearms comes with multiple benefits, such as reducing illegal firearm sales, assisting law enforcement in disarming dangerous individuals, and tracing firearms used in violent crimes, which is why six states and the District of Columbia have laws requiring registration of some or all firearms; and

WHEREAS, As public servants and the elected representatives of the people of Providence, the City Council has a moral obligation to keep firearms out of the hands of criminals in order to assure the safety of the people of Providence, and the State of Rhode Island.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council strongly urges the Rhode Island General Assembly to pass legislation requiring registration of all firearms.


