

Gentlemen:

Your Clerk by directive incorporated in Resolution 582, approved October 4, 1963, appeared before the United States Senate Commerce Committee Hearing in Providence on October 4, 1963.

The Hearing was conducted in the Federal Building in Providence, Rhode Island, and was presided over by United States Senator John O. Pastore.

By invitation of Senator Pastore, your Clerk read for the record the instant Resolution, a copy of which he filed with that Committee.

Upon completion of this presentation of the City Council's opposition to the discontinuance of the New York, New Haven and Hartford trains Nos. 508 and 521, which travels between New London and Providence, and to further register its opposition by bringing out that local state regulatory agencies, perhaps, should be the agencies empowered to determine the public convenience and necessity in local matters.

Senator Pastore at the conclusion of my testimony suggested that I transmit forthwith to The Honorable Harold D. McCoy, Secretary of the Interstate Commerce Commission, Washington, D. C., a duly certified copy of Resolution 582 and to further bring to the attention of the Secretary the fact that the subject matter appears on Finance Docket 2278.

Your Clerk respectfully reports that he did effect this transmittal by way of airmail, special delivery on October 4, 1963.
