Dear Councilman Annaldo:

The Smith Hill Center has submitted a proposal for affordable housing to this Department. The land for this project will be purchased through the Special Vacant Lot Program. These lots are in the Fillmore Street and Vesta Street area. (please see attached map)

Within this area are two (2) city-owned parcels. They are Plat 68, Lot 110, 15 Matthew Street and Plat 68, Lot 138, 16 Wiley Street.

The Department feels that this would enhance the developers efforts in making this area marketable.

Therefore, we are requesting that parcels located on Plat 68, Lots 110 and 138 be transferred to the Special Vacant Lot Program.
