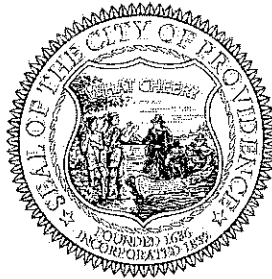

Resolution Requesting the administration to evaluate the feasibility of allowing property-owners to repair sidewalks and deduct the cost from their property taxes.

WHEREAS, Ensuring that roads and sidewalks are safe, easily navigable, and well-maintained is one of the principal duties of local government; and

WHEREAS, Many of Providence's sidewalks are cracked and in need of repairs, creating dangerous obstacles for pedestrians and posing safety concerns for residents; and

WHEREAS, The City Council Office has received numerous complaints from constituents whose sidewalks have been left in a state of disrepair for many years; and

WHEREAS, Twice in the last four years, the City of Providence has sought to borrow millions of dollars, at considerable interest rates, in order to finance road and sidewalk repairs; and

WHEREAS, Allowing property-owners to repair sidewalks adjacent to their properties and then deduct the cost of such repairs from their property tax bills would lead to faster sidewalk repair, would beautify neighborhoods by removing eyesores, and would help the City's financial situation by avoiding the costs of interest; and

WHEREAS, As the elected representatives of the people of Providence, the Providence City Council has a moral obligation to explore all options for improving governmental services and quality of life for residents.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby request that the Director of Public Works, the Tax Assessor, and the Tax Collector evaluate the feasibility of a program allowing property-owners to repair sidewalks adjacent to their properties and then deduct the cost of such repairs from their property tax bill.

BE IT FURTHER RESOLVED, That upon passage, copies of this resolution be sent to the Director of Public Works, the Tax Assessor, and the Tax Collector.

COUNCILWOMAN CASTILLO, COUNCILMAN IGLIOZZI, COUNCILMAN JACKSON

Resolution Requesting the General Assembly to change the calculation of Motor Vehicles for Excise Tax purposes.

WHEREAS, In 2014 at a joint event, Mayor Elorza described the motor vehicle excise tax as “regressive” and Governor Raimondo identified the State’s valuation process as a policy in need of reexamination; and

WHEREAS, Rhode Island State law currently requires that, for excise tax purposes, motor vehicles must be appraised at the “clean retail value,” rather than the “average trade in value”; and

WHEREAS, While most consumers are familiar with average trade in values, which are used by popular vehicle value guides such as Kelley Blue Book, many consumers are not familiar with clean retail values or how they are calculated; and

WHEREAS, Clean retail values artificially increase the appraisals of many vehicles because the calculation assumes that all vehicles are in good condition, while average trade in values rates every vehicle’s condition on a scale from “excellent” to “poor” and adjusts appraisals accordingly; and

WHEREAS, Moreover, clean retail values do not account for vehicle popularity, warranties, and other local market factors; and

WHEREAS, Due to these discrepancies between how clean retail values and average trade in values are calculated, clean retail values are almost always higher and average trade in values have gained a reputation as the more accurate estimate; and

WHEREAS, The use of higher appraisals that overstate the condition of vehicles from clean retail values disproportionately affects low-income residents, who are more likely to own vehicles in poor condition, increasing their tax burdens and harming their quality of life; and

WHEREAS, A process that systematically overestimates the values of vehicles or other property subject to taxation is inherently unfair and undermines citizens’ faith in their government.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby strongly urge the General Assembly to change the State Vehicle Value Commission’s process for valuing motor vehicles from utilizing clean retail values to utilizing average trade in values.

Resolution Requesting the Mayor to implement the recommendations of the Special Commission to Study Diversity and Equity in City Government.

WHEREAS, The City of Providence is committed to the goal of establishing a municipal workforce that reflects the backgrounds of the people of Providence; and

WHEREAS, The City of Providence draws strength from a diverse population with ties to multiple cultures and heritages; and

WHEREAS, On April 7, 2016 the City Council of the City of Providence passed a resolution establishing the Special Commission to Review Diversity and Equity in City Government; and

WHEREAS, Over the course of six months, the Special Commission reviewed the composition of the City's major departments from the standpoint of ethnic and gender diversity and equity, the current efforts to improve diversity and equity in those departments, and developed recommendations for further action; and

WHEREAS, On September 22, 2016, the Special Commission approved a final report on its findings and recommendations; and

WHEREAS, Proper implementation of the Special Commission's recommendations will be vital to promoting diversity and equity in City employment.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby request that the Mayor of Providence and his administration fully implement the recommendations of the Special Commission to Review Diversity and Equity in City Government.

COUNCILWOMAN RYAN

Resolution Requesting the Administration Conduct a Complete and Independent Audit of the Board of Licenses' Finances.

WHEREAS, The City Council received from Jeffrey B. Pine, Esquire, of the Law Office of Lynch & Pine, his review, report, and recommendations relative to the Board of Licenses, herein referred to as the "Pine Report"; and

WHEREAS, According to the Pine Report, "[I]t became apparent that the 'system' for the collection of fines/penalties really doesn't exist; the lack of enforcement of penalties with any degree of regularity is totally substandard, and this not only creates an accountability issue with the Board [of Licenses], but a fiscal issue for the City"; and

WHEREAS, The Pine Report states that, "An independent audit should be conducted immediately" and should cover "the collection of fines/penalties, and all other records and statistics of the License Office, including applications, letters of notification, license transfers, communications to licensees, agendas, minutes of meetings, records regarding violations, and online postings"; and

WHEREAS, It is of the utmost importance that the License Office properly track outstanding fines and penalties so that they may be collected and to ensure that licensees which fail to pay fines and penalties are held accountable; and

WHEREAS, The Providence City Council has an obligation to protect the financial health of the City, including the proper enforcement and collection of fines and penalties.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby request that the Mayor of Providence and his administration cause the completion of a complete and independent audit of the City's Board of Licenses, including but not limited to the collection of fines/penalties, and all other records and statistics of the License Office, including applications, letters of notification, license transfers, communications to licensees, agendas, minutes of meetings, records regarding violations, and online postings.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the Mayor, the Finance Director, the Internal Auditor, and to the License Administrator.

Resolution Requesting the Providence Police Department enforce the city ordinance related to Snowmobiles and Recreational Vehicles.

WHEREAS, Providence City Ordinance Chapter 15 Article VII defines the unlawful operation of snowmobiles and recreational vehicles, such as all-terrain vehicles (ATVs) and dirt bikes; and

WHEREAS, When operated unlawfully, snowmobiles and recreational vehicles pose a serious and potentially deadly threat to the pedestrians and motorists of Providence; and

WHEREAS, Many individuals continue to violate the City ordinance by unlawfully operating snowmobiles and recreational vehicles on public roadways; and

WHEREAS, On Saturday September 3rd, 2016, Fernando Serrano died in an accident while operating an unregistered dirt bike in the Mount Pleasant neighborhood; and

WHEREAS, According to the Consumer Federation of America, deaths while operating snowmobiles and recreational vehicles increased 10% during the first six months of 2016 compared to the previous year; and

WHEREAS, According to the aforementioned ordinance, the penalty for using a prohibited vehicle on City streets is a fine of five hundred dollars (\$500.00) and forfeiture of the snowmobile or recreational vehicle, as stated, "the Providence Police Department shall be empowered to seize and impound snowmobiles and recreational vehicles,"; and

WHEREAS, The Providence Police Department is charged with the duty to enforce City ordinances in order to bolster public safety and protect the people of Providence; and

WHEREAS, Providence City Councilors have a responsibility to ensure that all ordinances, especially those regarding public safety, are properly enforced; and

WHEREAS, The Providence City Council seeks to aid and assist the Providence Police Department as they carry out their difficult and important duties on behalf of the people of Providence.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council does hereby request that the Providence Police Department and its officers fully enforce Providence City Ordinance Chapter 15 Article VII; and

BE IT FURTHER RESOLVED, That, upon passage, a copy of this resolution be sent to the Mayor, the Commissioner of Public Safety, and the Chief of the Providence Police Department.

COUNCILMAN SALVATORE

Resolution Requesting the Department of Public Works Conduct a Study to Determine the Most Appropriate Locations for "Don't Block the Box" Intersections

WHEREAS, In the 2016 legislative session, the Rhode Island General Assembly enacted Rhode Island General Laws 31-15-12.2, "Don't Block the Box"; and

WHEREAS, This legislation allows the cities and towns of Rhode Island to designate certain intersections as "Don't Block the Box" intersections by ordinance to ensure the safe and free flow of traffic without obstruction; and

WHEREAS, Such intersections will be marked clearly with both white paint and "Don't Block the Box" signs designed by the State Traffic Commission; and

WHEREAS, In order to designate a State intersection located within a municipality as a "Don't Block the Box" intersection, the city or town must petition the State Traffic Commission for permission; and

WHEREAS, Effective January 1st, 2017, cities and towns will be allowed to fine motorists who "block the box" between \$100 and \$500, creating a strong deterrent to unsafe driving; and

WHEREAS, The act of "blocking the box," or obstructing an intersection, can have an outsized effect on traffic and safety in the surrounding area by causing back-ups and traffic jams at nearby intersections; and

WHEREAS, Such back-ups often leave motorists in unsafe positions in the middle of intersections and force pedestrians to weave in between vehicles on top of crosswalks or otherwise obstructing their ability to safely cross the street; and

WHEREAS, As the elected representatives of the people of Providence, the Providence City Council has an obligation to promote safety and ensure the free flow of traffic on city streets.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby request that the Department of Public Works conduct a study to determine which intersections would be most appropriate for the City to designate as "Don't Block the Box" intersections in accordance with Rhode Island General Laws 31-15-12.2, including but not limited to any intersections that would require the permission of the State Traffic Commission to be designated.

BE IT FURTHER RESOLVED, That the report be completed and transmitted to the City Council no later than December 1st, 2016.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the Mayor, the Director of Public Works, and the Traffic Engineer.

Resolution Requesting the administration and appropriate departments address the on-going garbage and litter issues in and around Iola French Park.

WHEREAS, Iola French Park is adjacent to Veazie Street Elementary School and the Wanskuck Library, making it a popular destination for schoolchildren, visitors to the library, and families who live in the surrounding community; and

WHEREAS, For more than a year, litter and garbage have been a serious issue at both Iola French Park and the nearby Veazie Street Elementary School parking lot; and

WHEREAS, Neighbors and Veazie Street School staff, have repeatedly reported that spectators and patrons of non-school events at the park do not properly dispose of garbage or clean-up the park after their activities have concluded, leaving the park in unsightly and even unsafe condition for others; and

WHEREAS, Veazie Street School staff, Parks Department employees, and neighbors have had to clean up the mess left by others, wasting City resources and educators' time, as well as trying the patience of members of the community who simply wish to enjoy their neighborhood park; and

WHEREAS, On September 2nd, 2015, a meeting was held with many City officials, including the Director of the Department of Public Property, to discuss the issues at the park; and

WHEREAS, According to a special report of the U.S. Department of Justice, from 2003 to 2012, domestic violence accounted for 21% of all violent crime in the U.S.; and

WHEREAS, According to the National Coalition Against Domestic Violence (NCADV), on a typical day, domestic violence hotlines nationwide receive nearly 21,000 calls; and

WHEREAS, In 2014 alone, 8,876 victims of domestic violence were served by domestic violence programs in Rhode Island, according to the NCADV; and

WHEREAS, Additionally the NCADV found that 11% of Rhode Island high school students have been physically hurt by a significant other, higher than the national average; and

WHEREAS, Victims are deprived of their autonomy, liberty, and security, and face tremendous threats to their health and safety; and

WHEREAS, A 2009 report from the Bureau of Justice Statistics found that children are present during 36% of domestic or intimate partner violence cases and, of those children, 60% directly witnessed violence; and

WHEREAS, According to the Childhood Domestic Violence Association, people who experience domestic violence as children frequently suffer from Post-Traumatic Stress Disorder, are 50% more likely to abuse drugs or alcohol, 74% more likely to commit a violent crime, and six times more likely to commit suicide; and

WHEREAS, Domestic violence costs the nation billions of dollars annually in medical expenses, police and court costs, shelters, foster care, sick leave, absenteeism, and non-productivity; and **WHEREAS**, Only a coordinated community effort will put a stop to domestic violence; and

WHEREAS, Several organizations in Providence work to raise awareness about domestic violence, assist victims, and promote healthy relationships, including the Rhode Island Coalition Against Domestic Violence, the Women's Center of Rhode Island, and Sojourner House; and

WHEREAS, Domestic Violence Awareness Month provides an excellent opportunity for people to learn more about preventing domestic violence and to show support for the numerous organizations and individuals who provide critical advocacy, services, and assistance to victims.

COUNCILMAN IGLIOZZI Requests the privilege of the floor to speak on a point of Personal Expression and states:

"I am going to use this time to give a quick report from the Finance Committee just to give everybody an understanding of what's going on. As you know, a few weeks ago the administration submitted a proposed precedent setting tentative five year contract with the Fire Union. Why I'm saying precedent is because the City Council, as many years as I've been on in the history has never ever approved a five year contract. By law it's three, but we will get into that detail later on I'm sure when you receive my letter. We can talk about more in detail, but I just wanted to give you a little status of what we have. At this moment in time, as you know the City Council and the people of Providence received a two to three page document with a bunch of hopefuls in it from the administration and they called it some type of tentative agreement. At this moment in time, as you know, the Internal Auditor and myself have forwarded several letters of inquiry with opposed questions. We have not received all those answers at this point in time, and of course, now there are even more questions as we move along with this. Third, as you all know there is no financial backup that has been submitted to date at all on any of this proposal. Next, as you all know, we haven't even received the full actual Collective Bargaining Agreement red lined to date. Also, even more important, we haven't received any fiscal note on this proposal. What I am hearing right now they're still working on it, which does give me some pause because I would think when they were negotiating for the past thirteen to fourteen months they would have done all those fiscal notes already to explain why the numbers or why their proposal numbers would even work in their submission that they submitted to us a few weeks ago, which is quite odd that they still haven't done a fiscal note, which it almost sounds like the old cart before the horse. So, that's very important to know at this point in time. So, all that information has not been presented or submitted by any witnesses, any financial witnesses or any information on this. So, I want the public to know, the council to know and my colleagues to know the status of it at this moment in time. Also, there has been no submission whatsoever pertaining to the administration's request to exercise, I like to call it the pension reform exception clause in the state statute, which would allow you to even go in to a five year contract, which is precedent setting. On another note, which I thought was very interesting and it actually kind of reminds me once again a little déjà vu, a couple of administrations ago there was a point in time where the administration was not being totally honest and truthful with the financial status of the City of Providence and at that time the Internal Auditor, not the present one the previous one was in the process. As you know, the City Charter has the authority to have access to all financial records and information in the City of Providence. That specific City Charter, as you know, is the constitution and the law and the reason why is the Internal Auditor needs access to everything on all those financials in order to have full disclosure and understanding what's happening. At that time that previous administration, what they did was as the Internal Auditor was investigating the process lo and behold that administration shut off the Internal Auditor's access to the financial information that actually happened, shocking as it seems. These weeks and months of battling eventually the City Charter prevailed, the law prevailed and the administration had to comply with the law and take away the blocks and open up the financials to the Internal Auditor, which as you know subsequently lead to

the \$100 million dollar deficit and the five hurricane warnings. Why I bring that up is because unfortunately just recently again in the past few days our present Internal Auditor unfortunately his access to the Fire Department's financial records were revoked. I will say it again, the Internal Auditor by City Charter who has right to all access to the city's finances, his access, the office access was revoked to the Fire Department's financial records. Ladies and gentleman, it's a violation of the City Charter. Luckily, level heads prevailed, the Internal Auditor addressed it, reminded all the parties, the Commissioner that the City Charter we all have to follow and I'm glad to announce that the Internal Auditor has access once again to the financial records of the Fire Department. It's kind of funny, you keep on seeing the same similar patterns, the same similar problems and people keep on thinking they can get around the Charter. So, I want to commend the Internal Auditor for his tenacity, to helping these individuals understand the error of their ways and getting back the access to the financial records. It's important that the committee, the council and the public have full disclosure especially since we're talking about this request for precedent setting five year contract. Thank you, Mr. President."


