Whereas, competent local and national authorities have indicated great concern for the present and future development of the Port of Providence in view of the apparent failure to obtain certain Federal approval of an appropriation for necessary preliminary engineering studies so that the navigable channel in the Providence River can be dredged to an adequate depth to accommodate the latest designs in cargo ships, and

WHEREAS, in the history of sea-going competition, Providence has always attracted and accommodated ships from American and foreign ports thus strengthening its position in World trade,

NOW THEREFORE BE IT RESOLVED, That in order to maintain this high level of operation and to keep on the safe course of future water terminal development, His Honor Mayor Walter H. Reynolds and the City Council most earnestly enlist the aide of the good offices of those Federal officials responsible for the promotion of this most necessary and pressing project that the channel in the Providence River be deepened sufficiently to attract and accommodate the draft of the latest designed cargo and passenger carriers so that Providence will receive its share of water-borne commerce, and

BE IT FURTHER RESOLVED, That a duly certified copy of this Resolution be transmitted by the Clerk to Rhode Island's Congressional Delegation in Washington.
