In accordance with Section 21-26 of the City's Code of Ordinances, I am writing to request that the following requested contract awards be submitted to the City Council and the Education Subcommittee for approval.

- *School Department* -- Approval of payment in an amount not to exceed \$146,081 to Henry Barnard School at Rhode Island College for the tuition of ten (10) kindergarten students and twenty-nine (29) students in grades 1-5.
- School Department -- Approval of the purchase of student lockers from Global Equipment Company of Port Washington, NY in an amount not to exceed \$32,620. This purchase is being made via a piggyback of a contract awarded in November 2013 by the school department.

Every year the Providence School Department selects several Providence students through a lottery to attend **Henry Barnard School at Rhode Island College**.




