## CHAPTER 1499

No. 566 AN ORDINANCE PROHIBITING THE SALE OF MODEL  
AIRPLANE GLUE TO MINORS.

Approved November 2, 1962

*Be it ordained by the City of Providence:*

SECTION 1. No person, firm or corporation shall sell or otherwise deliver or cause to be sold or delivered to any person under the age of 21 years any model airplane glue.

SECTION 2. No person having possession of any model airplane glue shall deliver possession thereof to any person under the age of 21 years knowing or having reasonable cause to believe that the same will be used as an inhalant.

SECTION 3. Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 10 of Chapter 10 of the Ordinances of the City of Providence, 1946, as amended. *Deed.*

SECTION 4. This Ordinance shall take effect upon its passage and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

## CHAPTER 1500

### No. 567 AN ORDINANCE PROVIDING FOR MICROFILMING RECORDS OF PROBATE COURT.

Approved November 2, 1962

#### Be it ordained by the City of Providence:

SECTION 1. The Clerk of the Probate Court is hereby authorized to microfilm the original records of the proceedings of the Probate Court hereafter filed in said Court and to further microfilm the reproductions of the original records of said Probate Court proceedings, which reproductions have heretofore been contained in bound volumes on file in said Court. The microfilm shall be on paper that complies with the minimum standards of quality approved for photographic records by the National Bureau of Standards. After completion of said microfilming all original records and bound volumes containing the reproductions thereof may be put in storage for safekeeping in such place as may be decided, by the City Council. A microfilms record shall be placed in conveniently accessible files in the Probate Court.

SECTION 2. This Ordinance shall take effect upon its passage.

That

the sum of Two Hundred Twenty Eight Thousand Seven Hundred Fifty (\$228,750) Dollars is hereby ordered transferred by the Commissioners of Sinking Fund from the Water Depreciation and Extension Fund to Special accounts in the Trust and Special Funds of the City of Providence to be known and in the amounts as follows:

Furnish and install Butterfly Valves at the Water

Purification Works \$ 110,000

Furnish and install Providence Standard Post

Hydrants to replace Flush Hydrants \$ 90,000

Furnish and install Two (2) New (Eight (8)

Million Gallons Daily) Wash Water Pumps at the

Water Purification Works \$ 20,000

Installation of new Water Main in Westminster Street \$ 8,750

The above amount of \$228,750 represents one half of the total estimated cost of the above listed projects to be completed under Public Law 87-658 known as Public Works Acceleration Act.

Said sum or so much thereof as may be necessary shall be expended and any balance remaining in said funds at the completion of said work shall revert to the Water Depreciation and Extension Fund.
