
Gentlemen:

In connection with a Resolution for an additional crossing guard at the Vineyard Street School, a survey was made to determine the number of children crossing at or near the intersection of Potters Avenue and Vineyard Street.

In the morning, when children are going to school, 18 students crossed at or near this location. At noon, when the kindergarten class is being dismissed and the afternoon class is arriving, none of the children crossed at this location.

When school is dismissed at 2:45 P.M., 36 children cross at this location.

It is the opinion of the Traffic Bureau that a crossing guard is not needed at this location. The children who have to cross Potters Avenue could cross at Potters Avenue and Dexter Street where a crossing guard is assigned, or cross at Potters Avenue and Bucklin Street at the traffic light.
