





WHEREAS, In a lifetime of service in all three branches of government, Governor Licht ever displayed the highest degree of integrity, compassion and professionalism,


NOW, THEREFORE, BE IT RESOLVED, That the Members of the City Council do pause in their deliberations out of respect for the memory of Frank Licht,






