That the City Treasurer, acting under the Direction of the Committee on Finance, be and he hereby is authorized and directed to borrow from time to time such sums as may be necessary, not exceeding five hundred thousand (\$500,000.00) dollars, in accordance with the provisions of Chapter 3251 of the Public Laws, passed by the General Assembly at its January Session, A. D. 1954, and approved February 11, 1954, entitled "An Act Authorizing the City of Providence to Issue Bonds in the Sum of Five Hundred Thousand (\$500,000.00) Dollars for Sewer Purposes" and to issue the City's notes therefor, bearing interest at a rate not exceeding three and one-half percentum (3½%) per annum, signed by him and countersigned by the Mayor and Chairman of Finance/^{Committee;} and to renew any such notes from time to time as the same become due. The money thus obtained is hereby appropriated for, and shall be exclusively used and expended for the purpose of constructing and repairing sewers and/or for the purpose of acquiring land or easements in land for sewer purposes.

RESOLUTION AUTHORIZING HIS HONOR THE MAYOR TO REQUEST THE GOVERNOR TO PROVIDE TECHNICAL PLANNING ASSISTANCE BY THE RHODE ISLAND DEVELOPMENT COUNCIL TO THE PROVIDENCE REDEVELOPMENT AGENCY

Whereas, pursuant to Resolution of the City Council No. 656, "A Resolution Approving the Filing of An Application for Federal Advance of Funds by the Providence Redevelopment Agency", approved December 17, 1954, the Providence Redevelopment Agency filed said application for financial assistance from the Housing and Home Finance Administrator under Title I of the Housing Act of 1949 for surveys and plans for the West River Project Area D7-R; and

WHEREAS, on February 8, 1955, the Housing and Home Finance Administrator and the Providence Redevelopment Agency executed a contract providing for the Advance of funds for surveys and plans of West River Project Area D7-R; and

WHEREAS, in the interest of using available technical personnel most efficiently to further the objective of industrial development so vital to the welfare of the City and the State, the Providence Redevelopment Agency is desirous of entering into a contract with the Development Council of the State of Rhode Island for technical planning assistance in connection with said project;

NOW, THEREFORE, BE IT RESOLVED, and it hereby is resolved, that the Mayor of Providence be authorized to direct to the Governor of Rhode Island the desire of this Council that he request the Development Council of the State of Rhode Island to negotiate with the Providence Redevelopment Agency for the purpose of providing technical planning assistance to the Providence Redevelopment Agency in connection with the West River Project Area D7-R.
