CHAPTER 1986-56

No. 638 **AN ORDINANCE** REGULATING GROUND COVER ON PUBLIC STREETS IN THE CITY OF PROVIDENCE, AS AMENDED.

Approved December 19, 1986

Be it ordained by the City of Providence:

SECTION 1. It shall be unlawful for the owner of undeveloped property to allow ground cover to extend in any public street, sidewalk or other public place. All ground cover shall be maintained at a height not to exceed twelve (12) inches from the ground.

The owner shall cause such ground cover to be removed in compliance with this Ordinance within five (5) days of receiving notice from the City of Providence.

SECTION 2. Any person or corporation violating any provision of this Ordinance shall be fined not less than Ten (\$10.00) Dollars, nor more than Five Hundred (\$500.00) Dollars, for each offense and a separate offence shall be deemed committed on each day on which a violation occurs to continue.

SECTION 3. This Ordinance shall take effect upon its passage.
