Dear Ramzi:




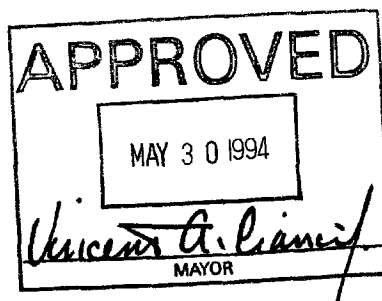
