Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 11 of Chapter 1419 of the Ordinances of the City of Providence, approved August 11, 1961; and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956, hereby reports concerning the proposed sale of real property within the Central-Classical Project No. R. I. R-2.

This Agency proposes to sell to the Church of God and Saints of Christ, a non-profit religious organization, a parcel of land containing 25,243 square feet of land, at thirty cents (30¢) per square foot for a total sale price of seven thousand five hundred seventy-two dollars and ninety cents (\$7,572.90).

The proposed redeveloper intends to improve this site by constructing a new church edifice for the congregation; said edifice which will contain a tabernacle with seating capacity for over 200 people, several classrooms, and offices. In addition, adequate off-street parking facilities and landscaping will be provided.

The submitted plans conform to all applicable ordinances and are in accordance with the official redevelopment plan for the project.

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 11 of Chapter 1419 of the Ordinances of the City of Providence, approved August 11, 1961; and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956, hereby reports concerning the proposed sale of real property within the Central-Classical Project No. R. I. R-2.

This Agency proposes to sell to John Hope Settlement House, a member agency of the United Fund, disposition sites 20A, 21, and 26A, which comprise a parcel of land containing 18,702 square feet of land, more or less, for a lump-sum price of \$13,898.50.

The proposed redeveloper intends to use this site, which fronts partially on Westminster Street, for the general purposes of the Settlement House, i.e. education and recreation, including the development of a nursery with necessary facilities, and re-adjustment of the present parking plan. The proposed development of said parcel would enhance both the facilities of the non-profit organization and the general amelioration of the Central-Classical Project and the City of Providence.

Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 11 of Chapter 1419 of the Ordinances of the City of Providence, approved August 11, 1961; and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956, hereby reports concerning the proposed sale of real property within the Central-Classical Project No. R.I. R-2.

This Agency proposes to sell to Hyman Levine and Samuel Levine d/b/a Hudson Fur Cleaning Company, a parcel of land containing 12,648 square feet, more or less, at \$1.00 per square foot for a total sale price of \$12,648.

The prospective purchaser has prepared plans for the construction of a one-story, 60 ft. by 15 ft., addition to their existing building. Such addition will allow for the continuance of the fur dry-cleaning segment of their operation which is presently functioning on a site within the Central-Classical project area which is scheduled for demolition. Since, through eminent domain proceedings, a necessary portion of their business will be dislocated, negotiations were conducted which have culminated in this prospective transaction. In addition, the prospective purchaser proposes to provide needed off-street parking facilities for 17 vehicles, as well as a service and turn-around area. The submitted plans conform to all applicable ordinances and are in accordance with the official redevelopment plan for the project.

The completion of such site developments will allow for the continuance of a firm which has, for many years, maintained a vibrancy of benefit to both itself and the City of Providence.
