RESOLUTION OF THE CITY COUNCIL



Dear Mrs. Brassil:

This Department found the building located at the above address open and accessible on June 22, 1978. The owner at that time was a Jacquelyn A. Bacon, address unknown. On March 22, 1979, this Department found the building occupied by a new owner, Ralph A. Ruggiero, of 127 Tell Street, who was living on the third floor.

On October 15, 1980, the building was again found to be vacant. Although the parents of the owner lived next door, they claimed to have no knowledge of the whereabouts of Ralph A. Ruggiero, their son.

After numerous attempts to locate Mr. Ruggiero, this Department boarded the property on May 6, 1981 at a cost of \$260.00. Prior to that time this Department also instituted legal action against Mr. Ruggiero and after several attempts, the Providence Police were finally able to locate him and bring him before the Municipal Court. On May 5, 1981, he was arraigned and the case was continued to May 26, 1981 so that he could make a decision as to restoration or demolition of the building. Mr. Ruggiero never appeared before the court again, even though a warrant was issued for his arrest.

On October 22, 1981, Mr. Viti, of New Homes for Federal Hill, contacted this office and told us that he could obtain a consent for demolition from Mr. Ruggiero if we would discontinue court action. Shortly thereafter a notarized release for demolition was mailed to this office and the City obtained bids and demolished the building for \$3,550.00, on January 12, 1982.


I have outlined this lengthy procedure in order to give you some idea of the efforts that were made by the City of Providence, both at this Department and at the Municipal Court level, and the lack of cooperation by the owner or anyone that had knowledge of him living in the area.

It is my understanding that the request for release of these liens is now being made by Ralph Ruggiero. Whether this is the son, Ralph A. Ruggiero, or the father, Ralph Ruggiero, does not seem to matter in this case since both made no effort to cooperate with the City of Providence when the building was opened or when this Department attempted to determine their plans for renovation or demolition of the property.

I see no valid reason at this point, after all the trouble this Department went through in attempting to keep the building safe, for the City of Providence to turn around and release all the liens on the property so that Mr. Ruggiero ends up with the property free and clear. If anything, since the houses are so closely spaced in this area perhaps the lot should be divided in half and each half sold to the adjoining property owners so that both could benefit by the open space made available by the demolition.

It is my recommendation that this petition be denied.
