PERSONAL EXPRESSION

COUNCILWOMAN WILLIAMS Requests the privilege of the floor to speak on a point of Personal Expression and states:

Mr. President I would like to speak in response to a recent letter of my colleague Councilman John Igliazzi which was sent to Commissioner McWalters and copies were sent to the Council, Mayor, Superintendent and the media. There was an article in the Journal and on television. It was announced that Councilman Igliazzi wanted to sell Hope High School. Besides being short sighted and simplistic it is insulting to the residents of the East Side and the Alumni of Hope High School. Hasn't the East Side lost enough schools already? Currently there are only two elementary schools, one middle school and one public high school. The residents of the East Side pay the highest taxes and we should not give up hope that all the children on the East Side might have the opportunity and deserve to have the right to a good education in the public schools. The suggestion proposed by Councilman Igliazzi is tantamount to throwing the baby out with the bath water. I have eight brothers and sisters who graduated from Hope High School. There are many proud Alumni of Hope High School. It is a valued and loved institution. Did you know that almost fifty years ago there was a recommendation to close Classical High School because it was an elitist school? That effort was fought vigorously by my friend Former Representative Sherwin Capstein and other East Siders. Over the years we have struggled to meet the needs of all of our students. The children with

disabilities, those with English as a second language, the college bound and even now we're looking to constantly find a way to prepare our children for the current work force needs. In addition, the following are reasons why the idea put forth by Councilman Igliazzi is wrong. Hope High School is not in his ward and he has no right to make such an outlandish recommendation for someone else's ward. Councilman Jackson and I with the approval of the residents of the East Side of Providence through the bond money invested millions of dollars to improve the fields, playground, tennis courts and green space at Hope High School. The Gilbane Company is right now evaluating the existing school buildings and that work needs to be completed. Hope High School is an historic structure which is well built and though it may need maintenance and repairs it would be fool hardy to demolish the building which is a landmark in the City. The problems and concerns about the programming at Hope High School is being dealt with by the Commissioner of Education, the school Superintendent and the Teachers Union and that process should continue to be worked out through the proper channels. I think it is dreadful and presumptuous for an individual Councilman and his constituents to try to impose such an off the wall suggestion like the one proposed by Mr. Igliazzi from another part of the City especially when the motivation is to capture a headline which I believe this was all about. Thank you.

PERSONAL EXPRESSION

COUNCILMAN IGLIOZZI Requests the privilege of the floor to speak on a point of Personal Expression and states:

First I rise on a Point of Personal Expression but I also thought there was a rule of the body that there was no personal attacking of each Council Member and I will abide by that rule and I will respect your position. I think what is interesting about it, is actually I want to say thank you because I'll tell you why. One of the major attempts I was trying to do is to spur debate and discussion about how to make the school system better and by you taking the time, energy and effort to what you wrote here today shows that you thought about it, you thought about the problems and concerns and by the way so do I. In fact if you remember a few years ago when I was trying to build three new schools in my neighborhood some of you and you in particular, you voted against those schools and that was in my neighborhood but that was okay. I didn't think that was an issue that was your prerogative but you know what? The three prong proposal is very simple. Hope High School is an antiquated building and it is going to take thirty million dollars to renovate it. It's on eighteen acres on the East Side overlooking the beautiful City of Providence. Most of the acres are vacant except for Hope High for a few acres. The Assessor has valued it at over 30 million dollars so what we're trying to do is we sell the property or sell a

portion of the property. We could still build one of the small Charter Schools on the portion of that property but we don't have to. Second, we relocate possibly all three of the proposed Charter Schools in the neighborhoods. As we all know 95% of the kids that go to Hope High I guess are being bused in and as you also realize that dropout rate has dropped out dramatically and one of the issues that was talked about was there is not enough busing. So we always talk about neighborhood schools so maybe we should try to get these high schools into the neighborhoods where the kids live. Third, as part of this innovative and I believe a very bold proposal was the idea to get a public and private partnership. I know this discussion is a little heavy but the understanding that we were able to move rivers as well as by the way two years ago this administration along with this Council's support was able to get these institutions, the very ones that I have been talking about here to help pay in lieu of taxes. No one ever thought that was going to happen and you know what was interesting about that, it was a Councilman from another ward who was putting pressure on most of the institutions that were not in his ward but we all understood the bigger picture which was to try to help the City of Providence. My proposal is about trying to get Brown University, Johnson & Wales, RISD, these are extremely high caliber internationally known institutions of higher learning. They have more

expertise in those halls of education than any of us could ever imagine. My proposal is about tapping into that expertise. Getting them motivated, getting them involved, creating and adopting for example a Vocational Charter High School that Johnson and Wales would do. You know being a plumber and electrician and a mechanic are extremely honorable professions. My grandfather, he bent wrought iron and I will tell you something. It is very lucrative and these are professions that are in need in this country and there is nothing wrong with giving our kids that option. When did that become such a bad thing? Next, arts, we're the Renaissance City that all of us at any given time as you Councilwoman Williams have stood up there and said we're the Renaissance City and we're proud of our arts program. Well, let's put our money where our mouth is and let's try to get an Arts High School. Let's try to get RISD motivated and get involved into our system and to provide an outlet for our kids. This isn't about you, it's not about me, it's not about this Council and it's not about any individual. This is a bitter problem, we have 28,000 students in the City of Providence and by the way folks that's about the population of the Town of Johnston. We need to get these kids the best education as possible and provide opportunities to them and give them different options. This isn't about an Alumni issue. Being that parochial is what's getting us into that problem. This is not a parochial issue, this is a

bigger issue. These 28,000 students live in all our areas and we should do everything we can to provoke discussion, try to change old mentalities that aren't working and they to get people motivated so we can maybe try something new. No one said you have to do this proposal but what it's about is discussion and trying new things. You know what's before the City of Providence right now is two things. We had numerous hearings by the way at Hope High, numerous hearings. The School Department presented their position which was simply saying let's stay the course or McWalters said he would like to take it over and appoint a Super Principal. Those two options aren't enough. Our kids deserve more and that's what this is about and to devalue any idea to try to make our school systems better devalues oneself, not the person you're trying to devalue and it saddens me that you can't think out of the box. Whoever thought you would ever have the rivers and the mall. Whoever thought you would ever have Masonic Temple being renovated or GTECH. Well folks, no one ever thought that but we thought out of the box together trying to make things happen and make this City the best place to live. That's what it is all about and that's why I proposed the proposal to try to get us all in this discussion and hopefully to motivate us all and think about other ideas. Thank you.
