REQUIRING THE REGISTRATION OF IDENTIFICATION MARKS BY ALL LAUNDRY AND DRY CLEANING ESTABLISHMENTS LOCATED IN THE CITY OF PROVIDENCE, WITH THE POLICE DEPARTMENT OF SAID CITY OF PROVIDENCE, AND PROVIDING FOR PENALTIES IN THE EVENT OF FAILURE TO COMPLY WITH SAID ORDINANCE.

It is enacted by the General Assembly as follows:

SECTION 1. The City Council of the City of Providence is authorized to adopt an ordinance requiring registration of identification marks by all laundry and dry cleaning establishments located in the City of Providence, with the Police Department of said City.

SEC. 2. Said Ordinance may provide a fine up to the sum of ^{two} ~~one~~ hundred ~~(\$100)~~ ^{\$200} dollars or imprisonment for not more than thirty (30) days for violation of said ordinance, or, in the discretion of the court, for both fine and imprisonment for each offense. This Ordinance may apply to all establishments engaged in the business of cleaning and finishing any wearing apparel, such as: hand and steam laundries, retail and wholesale cleaners, agents, agencies and all those engaged in this type of business.

SEC. 3. This act shall take effect upon its passage.

SUBJECT: REFERRAL NO. 570 - ZONING CHANGE ON PRUDENCE AVENUE

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, January 26, 1954.

This referral is a request for a change in zoning from an R-3 Zone to a C-4 Zone, Lot 365 on Assessor's Plat 110, located on the southerly side of Prudence Avenue, and containing 6,662 square feet of land area.

Reference is made to Referral No. 395, dated March 12, 1952, in which Lot 365 on Assessor's Plat 110 was petitioned for rezoning from an R-3 Zone to an M-1 Zone. Reference is also made to Referral No. 477, dated March 11, 1953, at which time Lot 365 and three other lots were petitioned for a change in zoning from an R-3 to a C-4 Zone. Both times the Commission's recommendations for denial were upheld by the City Council.

On the field trip it was found that the area in question is at present occupied by a vacant wooden structure damaged by fire, and construction equipment lies scattered throughout the area.

Even though the immediate area consists of light and medium businesses, it is felt that the surrounding vacant and residential areas should be protected from the intrusion of a C-4 Zone. Therefore, in order to avoid a case of spot zoning and to protect the character of the neighborhood,



SUBJECT: REFERRAL NO. 572 - ZONING CHANGE AT RESERVOIR AND NIANITIC AVENUES
(OPPOSITE PONTIAC AVENUE)

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, January 26, 1954.

This referral is a request for a change in zoning from an R-1 Zone to an M-1 Zone, Lots 19 and 25 on Assessor's Plat 126 located in the vicinity of Reservoir and Niantic Avenues, (opposite Pontiac Avenue) and containing a total of 66,389 square feet of land area.

On the field trip it was found that Lot 25, fronting on Reservoir Avenue, is at present occupied by a florist, and Lot 19 is occupied by the Rhode Island Ice Company. To the north of the area lies the dog pound, a building for the purpose of cremating small animal carcasses.

The introduction of an industrial zone in this area would adversely effect the development of this good residential area. Such districts have been prevented from reaching full usefulness by the establishing of unsuitable or inconsistent land uses either within or adjacent to the area. It is felt that this area should remain in an R Zone rather than an M Zone, which would allow any industrial use to be established on the property. Therefore, in order to protect the residential character of the area and to avoid a case of spot zoning
