RE: Resolution Requesting Change of Address

Dear Councilwoman Harris:

I am in receipt of your memorandum regarding the resolution requesting to change the address for the building identified as "30 Kennedy Plaza" and "63 Westminster Street" to "50 Westminster Street" and "90 Westminster Street".

After review, I respectfully oppose the address change for the reason that Westminster Street has odd numbers on the right side and even on the left. The numbering starts at 10, the Merchants Bank building, and 15, the old Hospital Trust building. The only exceptions are 1 Financial Plaza, which has a unique address, and 100 Westminster, the Paolino building (which according to GIS should have an address between 75-97 Westminster). This building is on the right side of Westminster Street, so it should have an odd numbered address. I do not believe it is in the interest of public safety to have even numbers on both sides of the street. It is confusing when responders do not have local knowledge of deviations from standard numbering practices, which happens when we rely on other cities to provide mutual aid.

Along with this opposition, I believe the city should require the Paolino building to change to an odd number for its address.
