NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby supports enactment of 85-H 5046 relating to larceny of public services and products or a like statute providing for penalties and a civil suit for larceny of public services and products and the City Clerk is requested to communicate said support to the Leadership of the General Assembly and Members of the Providence delegation.




Dear Rose:
