

I recently purchased a building at 406 Pine St. The dwelling is laid out into three apartments which I am now in the process of renovating both interior and exterior in the hopes of renting. The problem here is that the lot that the building is on is so narrow that there is not enough room for parking for my tenants.

This why I am writing you today concerning the lot adjacent to my property. After examining the city tax list, I discovered that this lot was quit claimed to the City of Providence on 12/1/69. The transfer is recorded in Deed Book 1100 page 420, plat 23 lot 111.

I have already spent considerable time in removing trash from this lot, but obviously ownership would be a further incentive toward further improvements. The sale of this land would benefit both myself and the city in that it would alleviate my parking problem and give me a yard and a vacant peice of property would be back on the tax rolls.
