



Dear Mike,

As you already know, FACTS Nursery houses six HIV affected and/or drug-exposed infants and toddlers. Because we are a non-profit organization we rely heavily on the Federal Work-Study program to provide us with childcare assistants in this nursery. These students serve as direct care providers for children in the custody of the Department of Children, Youth, and Families, and therefore, they must all receive a national criminal background check. In the past, the Providence Police Department has provided these students with this clearance.

Recently, the Police Department has made it clear to the students that they cannot receive a background check through the department because they are not Providence residents. Because the students are from various parts of the country, it is too great a distance for them to obtain a background check from their state of legal residence. It is also not very feasible for them to be processed by the State Police due to both time and transportation constraints.

It would be of invaluable assistance to us if you could please allow 10 students from both Brown University and the Rhode Island School of Design to be processed at the Providence Police Station. Feel free to call Julie Levesque at 467-9884 if you need any further information.
